## Twining Brook/Edenbridge Road, Cheadle Hulme - Additional Signage & New Road Markings

### Report of the Director of Place Management

### 1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To seek approval for the supply of, and installation of additional 20mph repeater signage and 20mph roundels (road markings) on Twining Brook and Edenbridge Road, Cheadle Hulme.

### 2. BACKGROUND

- 2.1. The local ward councillors have been approached by residents who have raised concerns in relation to 'some residents' speeding on the estate, particularly on the 'straight section' of Twining Brook as you enter the estate from Ladybridge Road, and have requested for additional signage and road markings to be installed at the T Junction on Twining Brook, to advise motorists the location has a 20mph speed limit.
- 2.2. Speeding falls within the remit of Greater Manchester Police therefore, we would urge residents to report such instances to the Police for potential enforcement.
- 2.3. The location is wholly residential. There is already 'gateway' signage installed on entry into Twining Brook from Ladybridge Road, together with repeater signage installed on Lighting Columns on both Twining Brook and Edenbridge Road.
- 2.4. Traffic Services have advised the local ward councillors:
  - 2.4.1. It is not possible to install 20mph roundels (road markings) at the T Junction as this is not in accordance with the Traffic Signs Regulations and General Directions (TSRGD).
  - 2.4.2. Consideration would also have to be given to Edenbridge Road and Twining Brook beyond the T Junction.
  - 2.4.3. Too much signage may make drivers become complacent.
  - 2.4.4. The installation of 20mph roundels (road markings) may become a maintenance liability.
  - 2.4.5. The installation of 20mph roundels (road markings) may affect the aesthetics of the estate and lead to complaints.
- 2.5. The local ward councillors have acknowledged Traffic Services comments.

### 3. PROPOSALS

- 3.1. To resolve the concerns raised, Traffic Services propose to install x2 further additional 20mph repeater signs together with x6 20mph roundels (road markings).
- 3.2. These proposals are shown on **Drawing No. NM36-Edenbridge Rd-002.**

### 4. LEGAL POSITION/IMPLICATIONS

4.1. None.

### 5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

5.1. No other alternatives were considered.

### 6. CONSULTATION

6.1. It is not necessary to carry out a consultation for these purposes.

7.1. The estimated cost of this scheme is £800. These costs include the supply of, and installation of the additional signage and all lining works including potential traffic management. These costs are to be funded from the Cheadle Hulme North Delegated Ward Budget.
