Chadwell Road and Marple Road, Offerton

Report of the Corporate Director for Place Management & Regeneration

1. INTRODUCTION AND PURPOSE OF REPORT

To approve No Waiting at Any Time restrictions at the junction of Chadwell Road and Marple Road in Offerton.

2. BACKGROUND

A resident on Chadwell Road (cul-de-sac) made representation to the Council about the lack of visibility of on-coming traffic when turning out onto Marple Road. In particular, there are issues in a westerly direction where the road curves away causing a blind-spot.

3. PROPOSALS

In order to improve the situation, a proposal was drafted for the provision of No Waiting at Any Time restrictions (double yellow lines) at the junction; with the lines extended to a total distance of 15 metres on the western arm of the junction. Please see the attached drawing number: **NM8-3088-001**.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

In agreement with the Ward Spokesperson a local consultation was organized on the above basis which resulted in the feedback summarised below:

Chadwell Road:

- 3 Respondents support the scheme.
- 3 Respondents support the scheme; but also suggest the proposed restrictions need to extend further on Marple Road (in a westerly direction) and something is also needed opposite the junction.
- Resident states he will not be happy if the proposals (when implemented) cause a displacement of parked vehicles from Marple Road into Chadwell Road.

Marple Road:

- The problem is visibility of on-coming traffic on Marple Road and therefore the restrictions do not need to extend so far into Chadwell Road (which will remove onstreet parking).
- The restrictions should extend further along Marple Road although this may cause a displacement onto Chadwell Road with related problems.
- Restrictions on the junction are a good idea however the proposed restrictions need to be shorter so as not to remove too much on-street parking.

Address not Supplied:

• 2 Respondents support the scheme.

General Comments (Network Management)

The current proposal has double yellow lines extending for a distance of 15 metres on the western arm of the junction. Extending the restrictions any further along Marple Road would displace parking causing visibility issues for residents in the frontage properties when exiting their driveways.

The introduction of double yellow lines on the opposite side of Marple Road would have to be treated as a separate matter. This is a strategic corridor and there is the question as to how far restrictions should extend (?).

The proposed yellow lines extend into Chadwell Road (6.5M wide) for a distance of 10 metres which is consistent with the guidance in the Highway Code. The guidance is to prevent conflict amid traffic turning in and out of a junction and to allow turning space for larger vehicles such as refuse wagons.

In view of the above, Network Management would recommend the proposal that went to consultation is reported to Area Committee for approval; and the Ward Spokesperson has indicated a willingness to proceed on this basis.

6. FINANCIAL IMPLICATIONS

Legal and Advertising £560 Road Lining £190

To be funded from the delegated Ward Budget.

7. TIMESCALES

If approved, the order is expected to become operative in 2023.

9. CONCLUSIONS AND RECOMMENDATIONS

The Area Committee recommends that the Cabinet Member (Highways, Parks and Leisure Services) approves the legal advertising of the following Traffic Regulation Orders and subject to no objections being received within 21 days from the advertisement date the following orders can be made:

No Waiting at Any Time:

Chadwell Road

Both sides from the Northern kerb line of Marple Road for a distance of 10 metres in a Northerly direction.

Marple Road

North side from a point 15 metres West of the Western kerb line of Chadwell Road in an Easterly direction to a point 10 metres East of the Eastern kerb line of Chadwell Road (to tie in with the aforementioned).
