<u>Proposed Traffic Regulation Order & Moving Traffic Regulation Order - Bridle Road,</u> Woodford

Report of the Director for Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To report the findings of a consultation exercise and to seek approval for the introduction of a Moving Traffic Regulation Order '20mph Speed Limit' on Bridle Road & Bridle Way, Woodford and a Traffic Regulation Order 'No Waiting at Any Time' (double yellow lines) on the junction of Bridle Road/Chester Road, Woodford.

2. BACKGROUND

- 2.1. It has been reported that motorists are parking their vehicles too close to the Bridle Road/Chester Road junction. Due to this inconsiderate parking behaviour, traffic movement on and around the junction is being hindered. This behaviour is also affecting visibility for all highway users using the junction.
- 2.2. These proposals will also compliment the Highway Rule Code 243 which states: DO NOT stop or park within 10 metres of a junction. However, due to the design of the highway an extension of the 10 metres is sometimes required, as is the case in this instance.
- 2.3. It has been reported that motorists are often speeding up and down Bridle Road. As this location is predominantly residential, requests have been made to reduce the current 30mph speed limit to 20mph.
- 2.4. An Automated Traffic Count (ATC) was installed during the period 24th June to 4th July 2022 where at which time the Average Speed was recorded as 19.9mph and the 85th%ile was recorded as 25.5mph.
- 2.5. Some areas of Bridle Road which are unadopted highway, with the addition of all Bridle Way, being unadopted highway. Therefore, prior to finalising plans and carrying out the formal consultation detailed within this report, Traffic Services contacted the residents of the unadopted areas to ascertain whether they wished the unadopted area of highway to be included within the 20mph Speed Limit Scheme. The outcome of the pre-consultation reflected 71% of the residents did want unadopted area to be included within scheme and 29% did not.

3. PROPOSALS

3.1. To address the parking concerns at the Bridle Road/Chester Road junction, it is proposed to introduce a Traffic Regulation Order 'No Waiting at Any Time' (double yellow lines). These proposals, which have been discussed with the local ward councillors, are shown on the consultation plan, **Drawing No. NM8-5195-WR Rev A.**

3.2. To address the reported speeding concerns on Bridle Road, it is proposed to introduce a Moving Traffic Regulation Order '20mph Speed Limit'. These proposals, which have been discussed with the local ward councillors, are shown on the consultation plan, **Drawing No. NM8-5195-SLO Rev A**.

4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

6. CONSULTATION

- 6.1. The Local Ward Councillors have been consulted and no adverse comments were received.
- 6.2. Greater Manchester Police have been consulted and have no objections.
- 6.3. No Waiting At Any Time proposals: from a total of 113 No. letters being delivered to residents, 47 No. (42%) responses were received, following which; 44 No. (94%) support the proposals and 3 No. (6%) do not support the proposals.
- 6.4. <u>20mph Speed Limit proposals:</u> from a total of 103 No. letters being delivered to residents, 42 No. (41%) responses were received, following which; 38 No. (90%) support the proposals and 4 No. (10%) do not support the proposals.

Following the comments received from residents during the consultation, and after careful consideration and discussions with the local councillors, the proposals have been amended. The revised proposals are shown on **Drawing No. Drawing No. NM8-5195-WR Rev C and Drawing No. NM8-5195-SLO-GA.** Additionally, as the location is a combination of both adopted highway and unadopted highway a further plan has been included to show highway status; see **Drawing No. NM8-5195-SLO-Highway.**

7. FINANCIAL IMPLICATIONS

7.1. Unfortunately, it is not possible to advertise proposals to introduce a Traffic Regulation Order (TRO) and Moving Traffic Regulation Order (MTRO) on the same legal advertisement notice. This is because a 'Static' TRO is decriminalised and enforced by the council whereas a 'Moving' (MTRO) is criminalised and enforced by the Police. Therefore, these proposals will incur two separate legal fees. The individual costs for each scheme are listed below, in 7.2.

7.2. 'No Waiting at Any Time':

The estimated costs of this scheme are as follows:

'20mph Speed Limit':

The estimated costs for this scheme are as follows:

Legal Advertising	£560
Lining – carriageway roundels	£600
Signage/Poles	£2,300

Funding for both schemes is to be paid from the Bramhall South & Woodford delegated ward budget.

8. TIMESCALES

8.1. 3-4 months, subject to objections.

Proposed Traffic Regulation Order (TRO) Schedule

No Waiting at Any Time

Bridle Road, Woodford (Both Sides)

From its intersection with the south eastern kerbline of Chester Road for a distance of 15 metres in a south easterly direction.

Chester Road (South East Side)

From a point 15 metres south west of the projected south west kerbline of Bridle Road to a point 25 metres north east of the projected north east kerb line of Bridle Road.
