Performing arts, Youth Group (drama education), Social activities (play readings, quiz, Theatre trips). Chads is run entirely by volunteers who pay a subscription to be a member. At its core Chads is about community and friendship. From giving young people confidence and social skills to tackling social exclusion and isolation for older members Chads is a welcome home for all in the community who use our facilities. All are welcome to join us.

We do not have a written equal opportunities policy. All posts within the Theatre are open to all members. Everyone is a volunteer and has equal status. Executive committee members and other committee members are elected at the AGM by the members.

2. About Your Application

9. Please give us a brief description of your proposed/planned project or activity

The money will be used to purchase a Defibrillator and an evacuation (stairs) chair. This has been prompted due to the death of an actor during a performance at another local theatre (Altrincham Club Theatre). That theatre management believes they may have been able to save the actor's life if they had a defibrillator on site. They have since purchased one.

We want to get an evacuation chair because we have recently had 2 instances where a member of our audience had become unwell and had to leave the auditorium. Both incidents needed the ill person to manage stairs to exit. Had the persons involved been unable to manage the stairs we would have had to cancel the performances.

Why we need funding?

Our reserves were depleted due to the Theatre being closed for 18 months due to Covid restrictions. Since re-opening in Oct 2021 we have seen a reduction in audience attendance of approx. 20%. Whilst this is slowly starting to improve, arts venues, professional and amateur, are not seeing the audience numbers returning to pre-pandemic levels. Consequently, we had a reduction of £8400 in our reserves in the 2021/22 financial year. Our annual electricity bill has gone up from approx. £10,000 to £20,000 and so we forecast a further reduction in reserves this financial year.

10. Who will benefit from this grant?

e.g. local residents, young people, older people and how?

The provision of a defibrillator and evacuation chair will benefit local residents, young and old, who come to Chads either as members of the theatre or as an audience member from the reassurance that help would be on hand should emergency strike.

Any local groups who hire Chads will also benefit. We are starting to see a return of local community groups and dance schools wanting to hire Chads. In this financial year we have had 4 hires; two dance schools, an Indian classical music concert and Onatti Productions performing live theatre in foreign languages for students of Cheadle Hulme school.

Our studio theatre is used weekly by a local drama school.

10(a) How Many Stockport residents will benefit?

Approximately 6000 residents this year and forecasting 7000 annually from 2024 as we gradually return to pre-pandemic audience levels and increase the number of outside lets.
