## Campbell Street, Reddish

Report of the Corporate Director for Place Management & Regeneration

#### 1. INTRODUCTION AND PURPOSE OF REPORT

To address an anomaly with the current one-way order on Campbell Street in Reddish.

#### 2. BACKGROUND

In has come to light that the current one-way traffic order on Campbell Street covers the full extent from Asquith Street to Mill Lane in that (northerly) direction. However, on-site the signage and road markings would suggest the order only covers that section from the car park entrance at the Police Station to Mill Lane (in that direction).

The current site layout is beneficial for the Police as they have the option of turning right out of the car park if traffic is queueing on Mill Lane. Therefore, a new order will need to assist this movement.

#### 3. PROPOSALS

The part-revocation is shown on attached drawing number: **NM8-4143-001**.

#### 4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

#### 5. CONSULTATION

A public consultation is not deemed necessary but letters will be delivered due the legal advertising to inform residents and police.

#### 6. FINANCIAL IMPLICATIONS

£600 for legal advertising funded from the delegated ward budget.

#### 7. TIMESCALES

The order is expected to become operative in 2023.
