It will significantly enhance the station for the community and for those visiting Middlewood.

It could attract new rail users with promotion of the project.

#### 10(a) How Many Stockport residents will benefit?

All rail users of services which pass through Middlewood, but mainly those who live in the area and use the train services. Pre-covid, the station had 21,000 entries and exits recorded. This reduced to just over 7000 during the pandemic and recent statistics are not available.

#### 10(b) Are there any restrictions on who will benefit from the funding?
