Moving Traffic Orders

Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To consolidate the Moving Traffic Orders currently on site.

2. BACKGROUND

2.1. It has come to light that the existing Moving Traffic Order in the form of banned movements was done under an Experimental Order however, this has never been made Permanent. These banned movements are still required to ensure the traffic movement at the junction is safe and continuous. Therefore, we are following the process to make these Moving Traffic Orders a permanent feature at this junction.

3. PROPOSALS

3.1. The proposals are shown in Drawing No. NM8-5233-01 and detailed on Appendix A.

4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

5.1. There will be no letter drop however, this will be advertised in the normal way with Notices displayed in the local newspaper, on-street and on the SMBC website.

6. FINANCIAL IMPLICATIONS

6.1. Legal Advertising Costs £650 To be funded from the Moving Traffic Order Scheme.

7. TIMESCALES

7.1. 3 months, subject to objections.

Appendix A

Proposed Moving Traffic Order Schedule

No Right Turn

Bramhall Lane, Stockport

At the intersection with Wellington Road South (A6), prohibited right turn – south eastbound.

No Left Turn

Buxton Road (A6), Stockport (Northbound)

At the intersection with Bramhall Lane, prohibited left turn - south westbound.

Wellington Road South (A6), Stockport (Southbound)

At the intersection with Higher Hillgate, prohibited left turn – north eastbound.

No U Turns

Wellington Road South/Buxton Road (A6), Stockport (South eastbound/North west bound)

Both directions from a point 14 metres south east from the south eastern kerbline of Bramhall Lane in a north westerly direction for a distance of 60 metres.
