1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 To seek approval for the introduction of a cycle access point and associated lining on Otterspool Road

2. BACKGROUND

- 2.1. Traffic Services has been asked to investigate the possibility of a cycle access point on Otterspool Road, as currently there is a shared path but no clear access point.
- 2.2. The ward spokesperson has agreed that measures are required to improve the access at this location.

3. PROPOSALS

- 3.1. To introduce cycle access to shared pedestrian cycle footway in the form of dropped kerbs and associated lining on Otterspool Road. Plus, additional lining to existing cycle access dropped kerb as shown on **Drawing No: NM18/OTTERSPOOL Rev A**
