The Marple Youth Project Community Interest Company (MYP CIC) is a safe space where young people can meet together to talk and/or enjoy free activities and games that are provided to young people living in the local area of Marple, and surrounding areas. The provision of support and activities are currently based in the Marple Methodist Church Hall and are supported by local volunteers. Current regular activities include art and crafts, football, basketball, wii console, Sony Playstation, guitar, piano, keyboards, and table tennis.

2. About Your Application

9. Please give us a brief description of your proposed/planned project or activityYou may wish to include details of what activities will take place, where will it happen, how often and who will take part. If you are applying for equipment you can tell us what will it be used for and why is it needed.

The youth club runs on Friday nights each week. The youth club takes place in the buildings connected to the Marple Methodist Church based on Church Lane in Marple. We have a regular roster of 11 volunteers supporting the MYP and the young people. Over the past year the Marple Youth Project had started supporting Stockport Council's HAF (Holidays and Food) programme in the Marple area. Myself and other volunteers at the youth project also have been running the Short Breaks programme in Marple. We have wanted to support the young people of Marple in this way but the Friday night youth club is still the most important part of what we do ; it's where we started and it is a place where young people can come and meet us and get some support as they socialise together. The equipment that we have added to the youth club is a set of plastic and iron clubs, to practise golf, and a mobile basketball ring. We are keen to work with the ideas that volunteers and young people have for activities and sessions they would like to see at the youth club! The young people had visited the climbing centre again during the past year. We currently allow a maximum of 40 young people in on each night that the youth club runs. The youth club runs every Friday night of the three school terms throughout the school year. There is a maximum ratio of 1 to 8, volunteers to young people, each night that a session is run; therefore there is a minimum of 5 adult volunteers at the Marple Youth Project each evening that it is open. Over the past 12 months we have had about 80 different young people from the local area attend at the youth club but we are building a steady group of around 30 who turn up regularly to see each other.

10. Who will benefit from this grant?

e.g. local residents, young people, older people and how?

Local young people in Marple and surrounding areas, their families and the wider community in Marple. We believe that local young people enjoy the activities on offer, or just being with their friends and peers at the youth club. We aim to support and empower local young people to have some fun, to explore conversations with others, and to take part in activities and games with other young people. This enables young people the opportunity to learn and grow in an environment that is different to their own households and schools. We believe that the youth club challenges the young people and allows them to improve their health and wellbeing, and that empowering them to enjoy this space and what it offers – and the chance to increase their confidence - is reflected in their actions at home, school and in the local community, in a positive manner.

10(a) How Many Stockport residents will benefit?

If there are 80 young people who have attended the youth club, this would have a direct impact on those 80, and an indirect impact on their friends and families. So if the average number of their friends and family was a factor of say 5, that could create a positive change to around 400

local people? The wider benefits to the community may include a reduction in anti-social behaviour where some young people have an outlet for their energies, a general increase in the health and wellbeing of local young people who use the youth club, and the indirect but noticeable affect on the culture of the local young people that attend at the youth club and therefore people that they come into contact with outside of the youth club as well. There have been real concerns mentioned locally about some of the behaviour of young people in Marple. We are working with some of the young people who have been identified in regard to incidents at the library and in Memorial Park. And we feel like we are starting to build meaningful relationships with some of the young people and that it is supporting a positive change in their behaviour.

10(b) Are there any restrictions on who will benefit from the funding?

The funding will only be used in the Marple Youth Project CIC which is a Community Interest Company and is therefore required to use its profits for the benefit of the community. The funding will only be used for spending on the running of the youth club.
