Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

To approve No Waiting at Any Time restrictions on part of Greg Street in Reddish.

2. BACKGROUND

Network Management received representation from a local Ward Councillor about the road narrowing (traffic calming) feature on Greg Street to the south of the junction with Wensley Road.

The feature has a cycle lane on either side of the pinch-points so that cyclists can pass through safely without being 'squeezed' by motor vehicles. It is reported that the cycle facilities are on occasions being obstructed by parked vehicles, which means the feature cannot be used safely as intended.

3. PROPOSALS

In agreement with the Ward Councillors, a proposal has been drafted to consolidate the feature with the provision of No Waiting at Any Time restrictions (double yellow lines) as shown on the attached drawing number: **NM8-3017-001**.

A letter of intent has been delivered (07 September 2023) to the immediate households to explain the reasons why the Council intends to make the Traffic Regulation Order (along with a copy of the scheme drawing). As and when the order is advertised by Legal Services (with a notice in the local press and posted on-site) members of the public will be entitled to register formal objections should they wish to do so.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. FINANCIAL IMPLICATIONS

To be funded from the delegated Ward Budget.

6. TIMESCALES

If approved, the order is expected to become operative in the earlier part of 2024.
