Chester's Croft is a Residential Park Home Site in Cheadle Hulme and is made up of a small community of 47 homes with 60 residents living therein. The site is specifically for people aged 45 years and above, and our community, being mainly the elderly, has an average age of 75 (the eldest resident being the grand old age of 96!).

In line with our community spirit, we have a Residents Association and hold meetings at least twice a year, with many social and charity events organised throughout the summer.

At our association meetings, the residents take the opportunity to present suggestions and ideas relating to aspects of park life which might enhance or improve the lives of those who reside here.

An example of this was a proposal that our park should, in light of the elderly generation residing here (who are only getting older), have easy access to a defibrillator, given that at that time, at least three of our members had received heart bypass operations for coronary heart-related illnesses. Sadly, one of those members has since passed away.

But this was seen as a sensible proposal that all residents could potentially benefit from, not least since there had been a recent instance whereby a resident needed medical assistance and had to wait 10 hours to be taken to A&E - the implications had this been coronary related would very likely have been severe.

So, on the back of this, we set about finding out how we could go about getting a defibrillator on site and ultimately set about raising funds so that we could purchase one along with a cabinet to house it in and the necessary pads and battery to support and use the device.

In March of 2022, having raised sufficient money, we purchased the device which has now been in situ for coming up to a year and happily, we can report that to date, we have not had the need to utilise it. However, the components of the device, pads and battery, have limited shelf lives and we now believe it would be responsible and prudent to think ahead for the time whereby we either need to buy replacement pads because they have been used or reached their use-by date, and/or the battery too, which will also expire in September 2024 and January 2025

Manchester Rugby Club supported us in our fund-raising activities and made a generous donation which helped us enormously. In addition to our own projects to raise money for the purchase of a defibrillator, a number of residents also very generously made personal donations to top up the funds. However, most of Chester's Croft residents are, in the main, pensioners and on fixed incomes and, whilst were very grateful in the first instance for their generosity, under the present economic climate and increased prices affecting the cost of living etc. this is not something we feel we can ask them nor expect them, to repeat. Furthermore, as fund raising becomes increasingly difficult, our options for raising more money are diminishing.

This application is being made to you in our capacity as a voluntary committee for Chester's Croft Residents' Association.

We had an incident on 19 September, whereby a member of the public needed to use our defibrillator as one of his relatives was having a heart attack. He had been wrongly directed to an address where a defibrillator no longer existed and was then re-directed to Chester's Croft. Sadly, by the time he got back home, his relative had passed away. Should our defibrillator pad had been used, we would have been in a difficult situation with no defibrillator pad available. We have since placed an order for a spare defibrillator out of our funds at a cost of £161.28

10. Who will benefit from this grant?

In line with our obligations in respect of siting the defibrillator at Chester's Croft, we have registered with 'The Circuit', which is our defibrillator network, who provide a nationwide overview of where defibrillators can be found. Many defibrillators never get used because emergency services don't readily know where they are or how to access them which can cost lives, and that's why this new infrastructure is so vital.

This means that along with the Chester's Croft community and nearby residents on Spath Lane East and beyond, people who use Manchester Rugby Club will also benefit, together with residents residing in the Cheadle Hulme/Bramhall and Woodford Ward Communities. Since we are also registered with the Northwest Ambulance Service, our defibrillator is also on their 'Circuit Map' for as and when the need arises. This has already happened and is described in Section 9.

We are in the process of exploring other sources where we can apply for funding and have established that we fulfil the criteria to apply to the Morrisons Foundation for funding. Whilst we have not yet made a formal application to them, it is our intention to do.

£1000.00 which is based upon a quotation (attached) from our preferred supplier, Kays Medical and the reason for this is as follows.

We purchased our defibrillator, the housing cabinet, defibrillator pads and battery from Kays Medical. From the outset, they demonstrated understanding and support and excellent, proactive customer service. Due to the Covid pandemic, at the point of ordering it transpired that there were supply chain issues across the whole of the UK, which was resulting in extremely long lead-times on the products we required. Because of this, and without hesitation, they kindly loaned us a defibrillator free of charge until they were able to fulfil our order. This included waiving any carriage charges.

Consequently, this service means we have a trusted and established relationship with this company who we feel sure would support and assist us in the event of any equipment or supply issues, and due to this, we have more confidence in continuing to use them for our ongoing needs, hence them being our preferred supplier.

We have also obtained quotes from two other suppliers who too could service our needs: -

£730.74 – from the DefibPad website (quotation attached) and

£916.80 – from St John’s Ambulance website (quotation attached)
