DC/088758 for the construction of a new detached two storey teaching block on the site of an existing sixth form college, to comprise of 10no. new classrooms, a staff room and supplementary flexible learning spaces, in addition to circulation space, WC provisions on both floors and plant and server space. The footprint of the building measured 681.2sqm, the surrounding site would be landscaped with paths, planting and include an external secure courtyard for use by students and staff at Aquinas Sixth Form College, Nangreave Road, Heaviley, Stockport, SK2 6TH, it was
