Good afternoon Simon,

Hope you are well.

We understand that a limiter device has now been installed at Bask and that you are hopefully ready for us to attend site to complete the calibration of the maximum PA noise levels.

In simple terms, this calibration process involves us increasing the volume of the PA system/limiter until we reach the threshold of the upper noise limits measured within the Holiday Inn bedrooms.

The sound source used is unpleasant to listen to (imagine extremely loud tv static) and the venue will need to be clear of customers and staff during the process - hopefully this will take no more than 30 minutes in total. As we're deliberately increasing the volume to the maximum limits, we would also note that the testing will need to be carried out **after 9am** to minimise disruption to hotel guests.

Based on the above, we would be grateful if you could provide information on the following so we can begin to co-ordinate our visit with the Holiday Inn:

- Confirmation that the limiter is installed in the PA signal chain and details of the device/model used.
- Indication of suggested dates/times which would be acceptable to undertake the testing and calibration

I'm at my desk most of this week if easier to call to discuss on the phone.
