Morning Benji,

Hope you're doing well.

I'm writing regarding the attached application to vary the Premise License at Bask essentially from 10.00-00.00hrs to 08.00-03.00hrs Friday, Saturday and Sunday.

I think we need to look at the existing Conditions and perhaps discuss altering or strengthening them to ensure that the License is more suited to a 3am finish.

Are you give me a bit of detail on how you currently operate, i.e;

- When (days/times) that you currently utilise Door Supervisors, and in what number (and between what times, and in what number, on a Sunday preceding a Bank Holiday Monday),
- The CCTV system currently in-place at the venue, which areas are covered by CCTV and the retention period of footage,
- How the venue will ensure that the over-consumption of alcohol doesn't become an issue,
- Details of the Drugs Policy which the venue currently operates, or will operate,
- Any policy on only using plastics outside (I appreciate that'll be more relevant to the summer months).

At the moment, I just need to understand how you currently operate and how you plan to operate going forward - it might be that we just need to reword some of the Conditions or formalise them on the License rather than introduce new ones.

Hey pal,

Not too bad thank you. How's things?

Sounds good to me.

- We currently have door supervisors on Friday and Saturday nights, 7pm - 2am x 5. Extra when we have match days, and also extra when we have events that would require adequate door team.

For Sundays going into the bank holiday, we'd be the same, 5 @ 7pm - 2am.

- We have 8 internal CCTV cameras. Main entrance, overlooking the booths, bar area, behind bar, toilet entrance, cellar, stage and kitchen area. Kept for 2 months.
- We pride ourselves on making sure our customers don't overstep the alcohol consumption. And the staff are very much clued up on who's on their way to having too much. Water offered, a breather outside. It's priority for us, ahead of selling more alcohol, that everyone is safe and in good health.
- We have drug policies around the venue, and in the toilets. With regular toilet checks happening throughout the evening. Bag searches upon entry to the venue.
- No drinks allowed outside after 10.30pm, and we start using polycarbonate containers for drinks from 10pm.

With the licence extension of 1 hour from 2am - 3am, we've never had any problems when the dispersal happens at the end of the night and everyone leaves to try and grab a drink in either the casino or Notion. We'll be giving out lollies to people leaving to keep any chat at a minimum.

Let me know if you have any other questions mate.

On another note, I know County Grimsby have had previous before. Are you expecting any trouble on Saturday?

Hi Benji,

I'm good thanks, I'm glad you are too. Thanks for coming back to me so quickly and sorry I didn't respond re the Grimsby game, I've only just now picked up your e-mail. Things are a little hectic here..!

Hope pre/post game went without incident anyway – I'm told that the trains from Grimsby were cancelled so I imagine there were less away fans than there otherwise would have been.

I'd actually forgotten that Bask now operates until 0200 each day – I was still under the impression that it was midnight. We actually spoke about the CCTV last year when the Premise License was updated to 0200, so I'm happy with the conditions already on the License.

The only thing that may be useful is to have something in writing re the number of Sia on weekends. If we were to say something along the lines of "A minimum of 4 Sia Door Supervisors will be utilised on Friday and Saturdays from 19:00 until close, and on any Sunday preceding a Bank Holiday Monday. At all other times, an ongoing risk assessment will be conducted by the DPS/Premise License Holder with regards to the necessity of Sia Door Supervision, and they will be utilised in the number and at the times deemed appropriate by said risk assessment" would that be agreeable? I don't want to make the License too onerous but being as you currently use 5 (which I'd still recommend going forward) what're your thoughts on having 4 stipulated for Fri, Sat and BH Sundays?

Do you currently use an Sia Register, too? As in, Sia Badge Holder's name, date/times worked, and Badge No?

How you operate with regards to polycarbs and no drinks outside etc is great, I don't think we need to have any other stipulations on the License.

It's always a really well ran premise which I'm grateful for!
