This application is for a 3 day music event to be held once per calendar year. The proposed licensable area is owned / controlled by Bredbury Saint Marks Cricket Club. The area includes the green space (2 x cricket pitches), the clubhouse, carpark for 52 vehicles with 4 disabled parking spaces. The area is approximately 35,000 M2 and has existing natural and made fencing around its boundary. This will be supplemented with temporary fencing. To gain entry into the venue during operating hours will be by pre-obtained tickets, with patrons having to comply with entry conditions. Any person under the age of 18 must be accompanied by an adult in order to gain entry into the venue. The entrance, exit and emergency exits will be well lit during twilight hours providing easy of access for any persons with accessible needs. A raised viewing platform will be located within the area for accessible patrons. Structures within the venue which will provide amplified sound will be positioned in locations which minimise noise pollution to the local area. To encourage the event to be family orientated there will be an area specifically for children and a fair.
An experience Personal Licence holder will be the Designated Premises Supervisor.

M Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

An Event Management Plan will be in place to cover safe site design, safe operations, onsite safety (including fire safety and relevant covid measures), safe access and egress, traffic management, child welfare, public nuisance, anti-social behaviour, security and reduction of crime. This will be made available on request to the licensing authority, or any other responsible authority described within the provisions of the licensing Act.

We will publish and apply conditions of entry to all patrons entering the venue. A reputable security company with a proven track record will be employed to manage and maintain these conditions. A reputable medical company will be employed to operate during operating hours. A child welfare officer will be onsite during operating hours.

b) The prevention of crime and disorder

A reputable security company will be employed to provide SIA registered staff. The number and types of stewards required will be determined by the security firm's own risk assessment. All security staff will be easily identifiable and have appropriate training for their duties. A CCTV system will be implemented at the event including cameras in place at the entrance/exit to capture everyone who attends the event. An electronic event control log will be kept at the event and be made available for inspection by responsible authorities. An alcohol management plan will be drafted prior to the event. All bar staff will receive training by the Designated Premises Supervisor. Training will include input on preventing underage sales, sales of alcohol to people who are drunk. A written record will be kept of all training carried out. This record will be kept on the premises and made available for inspection by any responsible authority. The Designated Premises Supervisor will maintain a written record of all members of staff who are authorised to sell alcohol.

c) Public safety

The event will be organised and carried out with due reference outlined in HSE 195, The Event Safety Guide (commonly known as the Purple Guide). Risk assessments will be carried out for activities on site. The substantial findings of the risk assessments will be recorded. This will also include a covid risk assessment, taking into account the latest government guidance and any other relevant guidance. An emergency evacuation plan, fire risk assessment, medical plan, search policy and prohibited items policy will be in place.

d) The prevention of public nuisance

An alcohol management plan will be in place. This will assist in reducing the levels of drunkenness and hence anti-social behaviour that may give rise to disturbance to local residents. Prominent, clear and legible notices will be displayed at exits requesting the patrons to respect the needs of nearby neighbours and residents and to leave the premises and the area quietly. Stewards will be available at the site perimeter to ensure satisfactory dispersal of customers after the event. An individual noise risk assessment will be carried out before the event and will be submitted to the local authority on their request. A suitably qualified noise consultant will be employed to help to plan the event and to monitor noise levels throughout the event. Deliveries of goods necessary for the operation of the business will be carried out at such a time during the day or in such a manner as to not disturb the local residents.

e) The protection of children from harm

The premises will operate a "Challenge 25" scheme at the premise in relation to age verification for alcohol sales and other age-restricted products. Signs and/or posters will be displayed in prominent positions inside the premise to inform customers of this policy.
 All children under the age of 18 must be accompanied by an adult.
 Child wrist bands will be used to easily identify children under the age of 18.
 A child welfare officer will be on site.
 A lost children's/vulnerable person's policy will be included as part of the event management plan.

Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.

- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

 4. For example the type of activity to be authorised, if not already stated, and give relevant further details, for example (but not exclusively) whether or not music will be amplified or unamplified.
 5. For example (but not exclusively), where the activity will occur on additional days during the summer months.
 6. For example (but not exclusively), where you wish the activity to go on longer on a particular day e.g. Christmas Eve.
 7. Please give timings in 24 hour clock (e.g. 16.00) and only give details for the days of the week when you intend the premises to be used for the activity.
 8. If you wish people to be able to consume alcohol on the premises, please tick 'on the premises'. If you wish people to be able to purchase alcohol to consume away from the premises, please tick 'off the premises'. If you wish people to be able to do both, please tick 'both'.
 9. Please give information about anything intended to occur at the premises or ancillary to the use of the premises which may give rise to concern in respect of children, regardless of whether you intend children to have access to the premises, for example (but not exclusively) nudity or semi-nudity, films for restricted age groups or the presence of gaming machines.
 10. Please list here steps you will take to promote all four licensing objectives together.
 11. The application form must be signed.
 12. An applicant's agent (for example solicitor) may sign the form on their behalf provided that they have actual authority to do so.
 13. Where there is more than one applicant, each of the applicants or their respective agent must sign the application form.

15. Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.

- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A **current** Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 17(3) or 18A (2) of the Immigration (European Economic Area) Regulations 2006, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or reasonable evidence that the person has an appeal or administrative review pending on an immigration decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:-
 - evidence of the applicant's own identity – such as a passport,
 - evidence of their relationship with the European Economic Area family member – e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;

- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

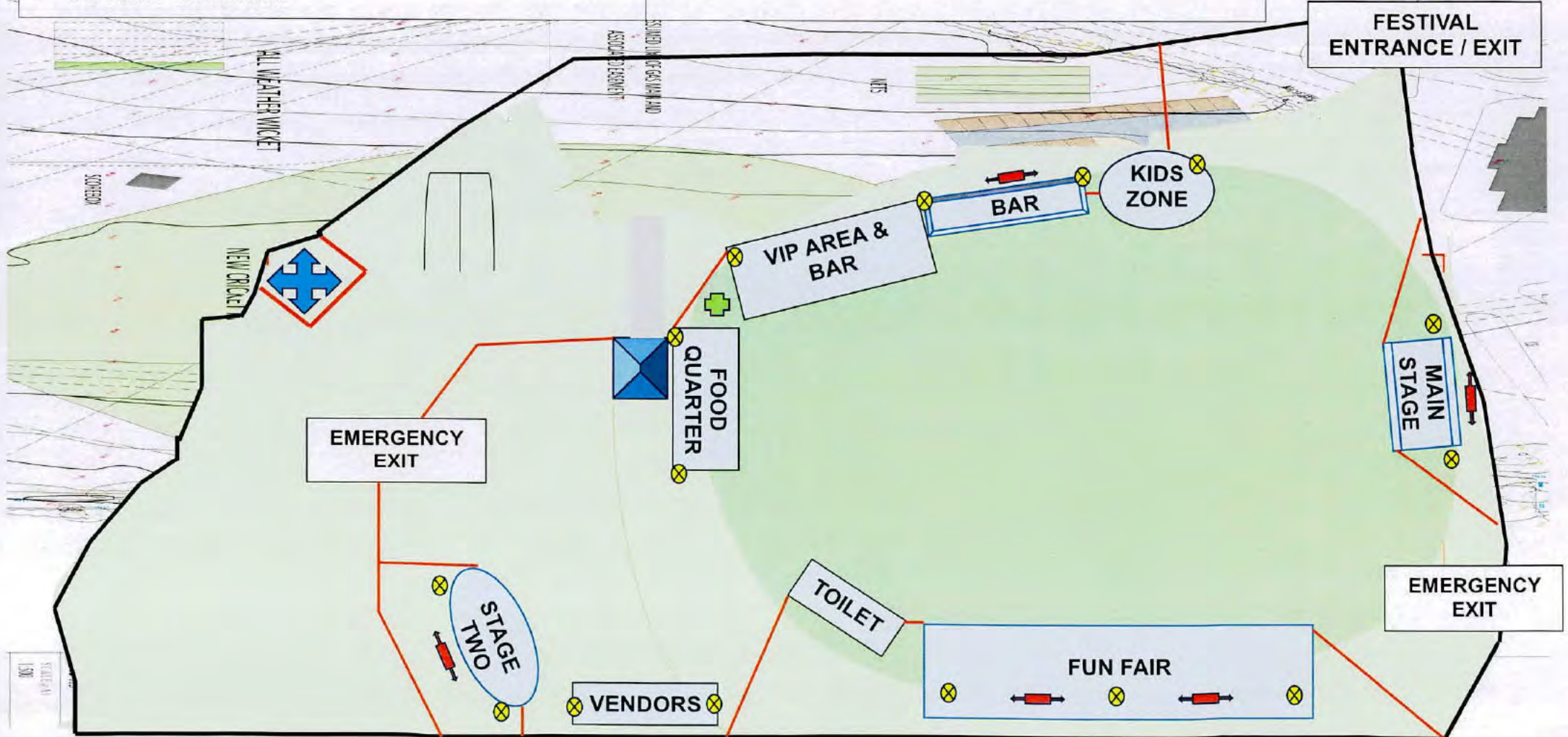
