

**THE ONE STOCKPORT HEALTH AND CARE PLAN 2024-2029****Report of the Deputy Place Lead****1. INTRODUCTION AND PURPOSE OF REPORT**

- 1.1 One Health and Care Plan (OHACP) is a single plan for health and care from 2024-2029, developed through extensive engagement with our local people. It builds on existing organisational strategies with the aim of improving support to local people through increased collaboration.
- 1.2 As ONE plan for health and care, this document replaces the CCG Strategic Plan, Stockport's Health & Wellbeing Strategy and our Locality Plan under the GM ICS Strategy, GM Joint Forward Plan and the One Stockport Borough Plan.
- 1.3 This Plan sits within the context of major national change in the organisation of the health service. The Health and Care Act 2022 established Integrated Care Systems (ICS) to deliver joined-up place-based working across health and care providers. This Plan is therefore focused on how we continue our transformation of the local health and care system as part of the Greater Manchester ICS, and crucially how we translate that in Stockport, with our Locality Board, Provider Partnership and in our neighbourhoods.
- 1.4 The One Health and Care Plan is a description of our strategic aims in line with our existing financial envelope and will be aligned to the opportunities defined by the Strategic Financial Framework that is currently under development.
- 1.5 The One Health and Care Plan is intended to be a high-level strategy outlining our ambitions for how we deliver that transformation.
- 1.6 Each priority will be underpinned by detailed 1-, 3- and 5-year delivery programmes that will follow agreement of the strategy. Each of these delivery plans will be accountable to the Locality Board through agreed sub-groups and sub-boards of the Board.

**2. BACKGROUND**

- 1.1. This One Health and Care Plan for 2024-2029 is a revision of the original version that was agreed in 2021. It was redrafted based on the request of the Locality Board, to align it to the Board's key priorities and to undertake further engagement and to provide an updated view on where we are now in 2023 and where we are going forward with respect to integration as part of the GM ICS as well as our journey to recovering from the pandemic and tackling the effects of the cost-of-living crisis.
- 1.2. The successful delivery of this long-term Plan is dependent on the successful collaboration of our Locality partners. The One Stockport Health and Care Partnership Board (Locality Board) aims to drive system-wide improvements in

population health and tackle health inequalities by addressing the social and economic factors which impact on health and wellbeing to help improve outcomes, quality of care, reduce health inequalities and maximise the value of public resources. The Locality Board will own the One Health and Care Plan. Monitoring and implementation will happen through the Performance, Improvement and Assurance Group; a sub group of the Locality Board.

1.3. Our vision for 2029 sees us all working together to develop a borough which is inclusive, caring, enterprising and full of ambition. We want to deliver healthier, happier lives for the people of Stockport; where people are enabled to live the lives that they want to and where children, young people and their families are enabled to realise their potential.

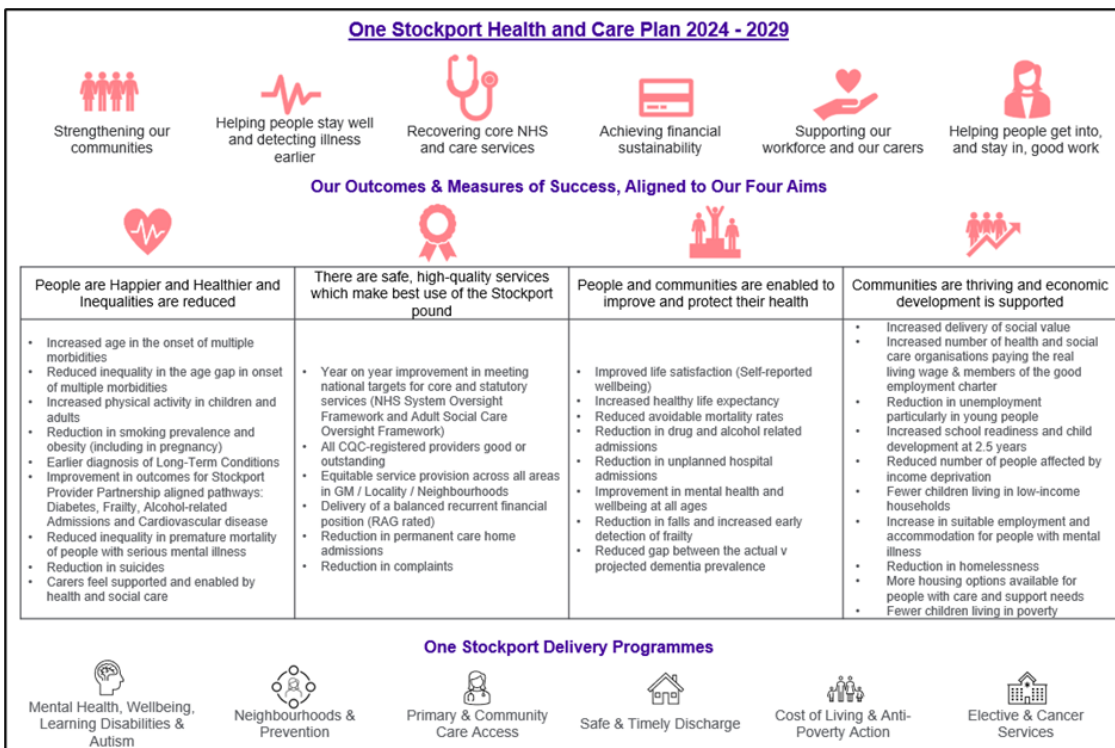
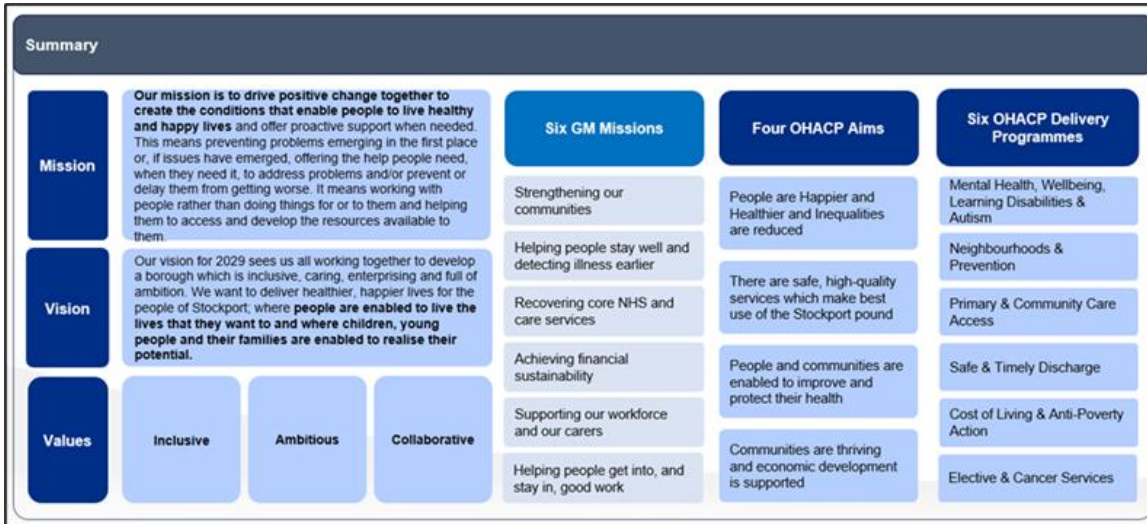
1.4. The One Stockport Health and Care Plan is the translation of that ambition in to a deliverable strategy. Since the inception of the GM ICS on the 1st of July 2022 our Locality Board and team has worked to align our resources and enablers to support integrated transformation against our four high level aims and to act on the Locality Board priorities, set out below:

- Cost of Living Crisis and Anti-Poverty Action
- Safe and Timely Discharge
- Mental Health, Mental Wellbeing, Learning Disabilities and Autism
- Neighbourhoods and Prevention
- Primary & Community Care Access
- Elective & Cancer Services

To achieve these six key priorities, there are additional areas of work that will be threaded through these workstreams to ensure successful delivery:

- Improving Urgent and Emergency Care
- Delivering Adult Social Care
- Supporting Children and Young People
- Enabling key delivery programmes including: Workforce; Quality; Performance, Improvement and Assurance; Estates; People and Community Voice; Finance

2.1 Each of these delivery programmes is aligned to the six missions of the GM ICS Strategy and to outcomes or metrics from the One Health and Care Plan Outcomes Framework which are in turn aligned to the four aims of the One Health and Care Plan – a Golden Thread running throughout everything we do - as outlined below:



### 3. HOW HAVE WE DEVELOPED THE ONE HEALTH AND CARE PLAN?

3.1 The Health and Wellbeing Board are asked to: The One Health and Care Plan for 2024-2029 has been influenced by

- Our engagement with the public.
- National and Greater Manchester wide strategy and policy.
- This is Stockport population health data / the Stockport Joint Strategic Needs Assessment.

3.2 Throughout 2021 wide engagement was undertaken with staff, patients, public and community groups to understand needs and aspirations. Feedback is detailed in the engagement report which will append the OHACP. This feedback has informed and shaped the draft plan. 2021 engagement highlighted the ongoing impact of COVID on our communities and a desire to increase collaboration across Stockport to

improve health and wellbeing.

- 3.3 In 2022 we undertook a 'light-touch' engagement programme with discussions held at the VCFSE Forum, Healthwatch Strategic Monitoring Group, Partnership Involvement Network, Primary Care Board and the People and Community Voice Engagement Group.
- 3.4 Throughout 2023 we embarked upon a period of yet more extensive engagement to appropriately inform the refresh of the Plan – we held focus groups with our equity networks, ran pop up engagement events in all of our seven neighbourhoods and in the town centre, a full read-through took place with Healthwatch Strategic Monitoring Group, we used the GM ICS survey and ran our own survey in our workforce and with VCFSE colleagues as well as face-to-face engagement events with our Locality workforce. We wanted to do engagement to TEST the proposed priorities and to SHAPE the content of the priorities. This engagement resulted in us updating our aims and adding two additional priorities to the four originally agreed by Stockport Locality Board. (The additions were Primary Care Access and Elective and Cancer). As well as updating the content of our original priorities that the public were overwhelmingly in support of; the public were engaged, and were supportive of the wider vision and the four aims.
- 3.5 A full analysis has been undertaken with Quality and Safeguarding colleagues in health and social care to ensure that this plan centres on quality and getting it right for our population, and that this will be demonstrable for the locality and the Local Authority when it comes to providing evidence to any regulatory body such as Care Quality Commission or others.
- 3.6 It is recognised that prior to full release an easy read and web version will need to be finalised.
