<u>Additional Parking - George Street, Compstall</u>

Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 This report is to review the parking provisions outside the local post office on George Street, Compstall and to consider changing the usage of the current bays.

2. BACKGROUND

- 2.1. A request was received from ward members to look at available options for parking on George Street, in front of the Post Office. Currently there are four parking bays which can be used by anyone, with no time restriction.
- 2.2. Vehicles parking for long periods of time are having a detrimental effect on the local businesses affecting custom and deliveries.

3. PROPOSALS

- 3.1. Members may recall the report from 29th November 2023 regarding the Resident Parking Scheme (RPS) application, and our recommendation to carry out observations over several months to assess the impact of the temporary RPS in relation to Etherow Country Park car parks and the surrounding area.
- 3.2. Whilst carrying out these observations there is an opportunity to address the long-term parking adjacent to the Post Office, giving us the option to introduce an Experimental Traffic Regulation Order (ETRO) of limited waiting within these bays to see if this helps to alleviate the issues. The proposals shown on **Drawing No NM8-5004 REV A** include:
 - Introduction of an additional limited waiting parking bay fronting the Post Office.
 - Changing 3 of the existing bays to limited waiting.
 - Leaving one bay unrestricted.
 - For clarity each restricted bay will have its own sign to advise of the waiting times to ensure that the unrestricted bay is easily identifiable.
- 3.3. The proposed waiting restrictions are 1 hour waiting, no return within 1 hour.
- 3.4. These proposed parking restrictions will be observed as part of the overall surveys taking place in the area over the coming 12 months.

4. CONSIDERATION OF ALTERNATIVE SOLUTIONS

4.1. This is an Experimental Traffic Regulation Order which may change as a result of comments received over the implementation period.

5. CONSULTATION

5.1. No consultation is required for the Experimental Traffic Regulation Order. These are introduced for up to 18 months with a review after 12 months. This counts as the consultation period. However, these proposals were discussed with the Post Office who are in support of an experimental order.

6. FINANCIAL IMPLICATIONS

6.1. £2,000 to be funded by the Marple North Delegated Ward Budget

7. TIMESCALES

7.1. Expected implementation early 2024.

Limited Waiting 1 hr no return 1 hr

George Street
North West Side

From a point 6 metres southwest of the northeast building line of 229 Market Place for a distance of 5.5 metres in a south westerly direction.

George Street

Southwest Side (adjacent to Market Place)

From a point 4.5 metres from the northwest kerb line of George St for a distance of 6m (3no, 2-metre-wide perpendicular parking bays) Measurements from George St kerb line are taken from the east side of Market Place
