Brookfield Park Shiers Family Trust Application Form



Thank you for your interest in the **Brookfield Park Shiers Family Trust**. Money from the sale of Brookfield House has been used to set up an award scheme for the benefit of local community and voluntary groups. The property was left to the then Cheadle and Gatley Urban District Council in June 1945 by a Deed of Gift by Percy Hesketh Shiers. Decisions about who receives awards are made by councillors who sit on the Cheadle Area Committee.

The objectives of the Trust are that the land and the trust funds are used for health, educational and services in the area of benefit, namely that of the former Urban District of Cheadle and Gatley. This includes most of the current Cheadle and Gatley, Cheadle Hulme North, Cheadle Hulme South and Heald Green Wards, and parts of the Bramhall North, Bramhall South and Davenport and Cale Green Wards.

Guidelines for the distribution of monies from the Trust:

- Invite applications for projects by voluntary and community groups in the area of the former Cheadle and Gatley Urban District Council, to include both enhancements of existing projects as well as new projects.
- There is no upper limit on the amount that may be applied for and any applications and grant amount awards will be considered on a case by case basis. Groups are permitted to submit further applications once a project was more advanced.
- There is an expectation that applications will include innovation, imagination and good presentations for proposed projects, and that proposed projects work for the good and betterment of the community.
- Attach a grant condition requiring the money to be spent on residents within the Trust's area, even if the organisation applying for the grant is located outside the area of benefit of the Trust.

Aims that projects should seek to support:

- address the effects of loneliness of residents and the consequential effect on their health and wellbeing;
- support voluntary groups and sports groups for residents of all ages; and
- support increased accessibility in district and local centres.



6. Please describe the main activities of your organisation/ group

We are a voluntary local community group focusing on education and Persian poetry. The group formed in 2011. We meet up weekly, through Zoom, and have occasional in-person meetings to visit galleries, libraries and exhibitions. We also get together once a year for our annually session.

We mostly read Shahnameh (the book of Kings) or other poems or stories with humanity and discuss how the subject affects us and makes us feel. The sessions are run in English and Persian, depending on people who join us in each session.

Shahnameh is a book of poetry written over 1000 year ago. Shahnameh as well as stories from the past contains universal human values that are still relevant. Shahnameh's stories contain some women, people of mixed race and refugee characters that had to move to new countries to survive. These and topics such as the importance of good deeds, helping others and kindness are aspects that a lot of our members can relate to. In our group we pause on stanzas particular referring to the harm of revenge and war, topics that unfortunately are still timely.

Since the pandemic our role changed to include support role as well. Increasingly we found ourselves required to deal with problems of isolation and mental health issues. We sometimes invite professionals to talk to our members about the importance of looking after yourself mentally and physically. These professionals are Persian speaking members of our community. Since having our website and regular Zoom sessions we are in constant dialogue and aware of each other's well-being and health.

9. Is this a new project/ initiative or an enhancement of an existing one?

This is an ongoing project but each year we tailor it to enhance the work so it can address the need of the community and appeal to new audiences.

10. Please give us a brief description of your proposed/ planned project or initiative and details of any existing activities, in line with the aims that projects should seek to support, along with broad numbers involved

We run regular weekly and monthly meetings including poetry workshops and visits to cultural venues (such as galleries, libraries and museums). We help members of Persian speaking communities have access to the Persian literature e.g. by running poetry workshops and book exchange programmes. We run book clubs where we read together as well as providing opportunity for people to recommend further readings and share their knowledge. We have sessions in English and Persian so English speaking community members who would like to join us can do so. In this way we help with integration in the society.

In our annual celebration we collaborate with academics, local artists and other local cultural groups to celebrate diversity and to learn from each other. This year our annual celebration falls in the 12th May and will be held at Rethink Rebuild Society Discovery House, SK4 5BH.

We run our sessions for free and rely on members who can pay to cover some of the costs for those who are unable to pay by asking people to donate. In the past we have worked with Sahba (a music academy based in Manchester), Commonword (a writing organization based in Manchester), Doosti (a support group for refugees and migrants based in Salford), Sheba (a women-led community arts organisation based in Manchester working with refugee and migrant communities). We have also worked with academic such as Professor Charles Melville, Dr Firozeh Melville and Dr Mahmood Kavir who have offered their supports in kind. We also collaborated with publishers from London to showcase their Persian books in our event.

Since 2021, when we first had our Zoom accounts, we ran 127 free poetry workshops and 20 annual or larger free public meetings most of our activities were full to the capacity.

Most of our costs include:

- The cost of running our annual events:
 - -Advertising, designing and printing leaflets
 - -Hiring a venue for annual session
 - -Refreshments
 - -Expenses for our speakers
 - -Technical support for sound and PowerPoint





- The cost of running our on-line events:
 - -Annual subscription of zoom
 - -Annual domain cost for website
 - -Annual subscription for hosting website

11. Who will benefit from this grant?

We are a unique group running sessions in English & Persian, so language barrier issue in Persian speaking communities is addressed. Local residents interested in exploring other cultures, Persian speaking communities of migrant and refugee backgrounds (ie, Afghan, Tajik, Arab and Iranian), adults of all ages, families, second generation migrants who want to learn about their heritage are all examples of community members likely to join us and benefit from this grant.

11(a) How many residents within the area served by the trust will benefit?

We are sending the invite to over 300peple in Stockport area. In the past most of our activities were full to the capacity. We even had sessions where over 200 people attended. Last year we hired a smaller venue to keep the cost down. Many people were disappointed not to be able to join us. This year we can accommodate 130 people for our annual events. Our online workshops are through zoom and anyone can join us. We are not aware of any limitation for inline sessions.
