## **1. Introduction and Purpose**

- 1.1 Policy priorities for 2024/25 were set out within the Council Plan, which was adopted at the Budget Council Meeting in February. This incorporates the shared outcomes from the Borough Plan alongside specific priorities of the Cabinet. These priorities are articulated within the portfolio agreements, which form the basis for regular in-year reporting.
- 1.2 The agreements have been aligned with the seven cabinet portfolio responsibilities. Work has since been undertaken to review and update portfolio priorities in conjunction with portfolio holders, and these are presented to the first available Scrutiny cycle for comment.
- 1.3 Portfolio and Performance and Resource Reports (PPRRs) will assess progress against key objectives, priorities, outcomes and budgets, enabling Scrutiny Committees to hold the Cabinet to account and for the Cabinet to identify current and future risks to delivery.
- 1.4 This report presents the draft 2024/25 Agreements for **Climate Change & Environment** and **Economy, Regeneration & Housing** Portfolios for consideration and comment by the Committee.

## **2. Content of Portfolio Agreements**

- 2.1 The Climate Change & Environment Portfolio includes the following areas of responsibility:

*Climate Action Now (CAN); Sustainability; Waste Collection and Recycling; Clean Air; Civil Resilience.*

- 2.2 The Economy, Regeneration & Housing Portfolio includes the following areas of responsibility;

*Planning; Housing Capital & Strategic Housing; Economic Growth; Employer Engagement; Inward Investment; Building Control; Markets; District Centres; Adult Education; Apprenticeships.*

2.3 Following consideration and comment by Scrutiny, final versions of the Portfolio Agreements will be presented to the Cabinet for approval on 25 June 2024 and Portfolio Dashboards will be updated ahead of the Mid-Year Reports in the November 2024 Scrutiny Cycle and again, ahead of the Year-End Reports in the June 2025 Scrutiny Cycle..
