Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

To approve Restricted Waiting (No Wating Monday to Saturday 8.00am – 6.00pm) on part of Brent Road in Heaton Norris.

2. BACKGROUND

Network Management at Stockport MBC received representation about the parking situation on Brent Road which is part of Green Lane Ind. Estate. Frequently, the Highway is double-parked, and this can seriously hinder the day-to-day activities of units which need clear and safe access for their operations.

Obviously, the layout of the estate is historical and not suited for modern levels of vehicle ownership / activity. Nevertheless, the Public Highway is for the passage of all road users.

3. PROPOSALS

In order to improve the situation, a proposal was drafted to extend the existing single yellow line restriction (No Waiting Monday to Saturday 8.00am-6.00pm) as shown on drawing number: **NM8-5232-001**. Note: The Traffic Regulation Order (TRO) applies from the middle of the carriageway to the back of the footway on that side; therefore, vehicles parking fully on the footway (as is occurring daily) would not be exempt from the order.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. CONSULTATION

A consultation delivered to all premises on the estate resulted in two responses from units on Brent Road who fully supported the scheme for the reasons explained.

6. FINANCIAL IMPLICATIONS

7. TIMESCALES

If approved the order is expected to become operative in 2024.
