## **Gorton Road, Reddish**

### **Report of the Director of Place Management**

#### **1. INTRODUCTION AND PURPOSE OF REPORT**

To approve No Waiting at Any Time restrictions on part of Gorton Road in North Reddish.

#### **2. BACKGROUND**

A Ward Councillor contacted Network Management to raise concerns about the western side of Gorton Road between Wentworth Road and the Glass Merchants next to Gainford Road. Currently we have a situation whereby vehicles are frequently parking on the footway (where it is unrestricted) and this is causing a serious obstruction for pedestrians – especially wheelchairs and pushchairs users.

#### **3. PROPOSALS**

In order to improve the situation, a proposal was drafted to extend the existing No Waiting at Any Time restrictions (double yellow lines) from the junction at Wentworth Road to the Bus Stop Clearway fronting the said premises. Please see the scheme shown on drawing number: **NM8-5246-001**. Note: The legal Traffic Regulation Order (TRO) applies from the middle of the carriageway for the full width of the Highway (Inc. footway) on that side. Therefore, vehicles parked fully on the footway would not be exempt from the order.

#### **4. LEGAL POSITION/IMPLICATIONS**

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

#### **5. CONSULTATION**

In agreement with the Ward Councillors a local consultation was delivered on the above basis. This resulted in a number of responses from occupants on Wentworth Road who were not necessarily opposed to the restrictions; but were deeply concerned about more vehicles from the local car showroom being displaced onto their street. They report already experiencing the following issues:

- Cars associated with the business (Inc. untaxed vehicles) monopolising on-street parking spaces.
- Parked vehicles interfering with safe access to lowered-kerb driveways.
- Repairs being undertaken on the Highway with vehicles obstructing the pedestrian footway.
- Conflict between staff and residents which has led to Police involvement.

In view of the above, a number of the respondents suggested a permit scheme for Wentworth Road if the proposal goes ahead.

**Network Management Comments:**

Gorton Road is a Strategic Route, and it is essential the scheme is implemented to prevent the footway being almost completely obstructed (as has been witnessed).

A permit scheme would not be justified as all the properties have provision for off-street parking.

It is an offence to obstruct a lowered-kerb driveway and occupants can request enforcement if this situation is happening without their permission.

Repairs and maintenance being undertaken on the Highway can be reported to the Council’s Neighbourhoods Team as an environmental issue.

An untaxed vehicle on the Public Highway can be reported to the DVLA via their website.

As and when the TRO is advertised by Legal Services, occupants on Wentworth Road will receive notification in writing of the above.

As a gesture of goodwill, the Ward Councillors have made it known they would like to offer residents on Wentworth Road the provision of a FREE Access Line (or H-Bar) marking. The usual cost for this facility is £196 payable by the householder(s) which covers future maintenance of the facility.

**6. FINANCIAL IMPLICATIONS**

Legal and Advertising	£650
Road Marking	£300

To be funded from the delegated Reddish North Delegated Ward Budget. The cost for Access Line markings to be agreed separately with the Ward Councillors.

**7. TIMESCALES**

If approved the order is expected to become operative in 2024.
