Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

- 1.1 Ward Councillors have requested a traffic, signals and road safety study to be conducted by the Highways & Transportation Service at the area of Councillor Lane and Ladybridge Road in Cheadle East & Cheadle Hulme North.
- 1.2 A budget of £4000 was originally dedicated from the Delegated Ward Budget to support this work.
- 1.3 The purpose of this report is to request the allocation of £4000 for this work from Ward Discretionary Budget, as opposed to the Delegated Ward Budget.

2. BACKGROUND

- 2.1. In 2023/24, Cheadle East & Cheadle Hulme North ward councillors agreed a study to look at potential design and signal issues around the junction of Councillor Lane and Ladybridge Road in Cheadle East & Cheadle Hulme North.
- 2.2. The original agreement was that a £4000 budget from the Delegated Ward Budget was used to fund the traffic study.
- 2.3. The close-out of the Discretionary Ward Budget in 2023/24 financial year had some funding remaining that has been held over by Democratic Services to fund the traffic study.
- 2.4. Proposals for this change have been delayed in being brought to Area Committee, but the funding has been budgeted in the 2023/24 Discretionary Ward Budget and will be dispersed on approval of this report.

3. PROPOSALS

3.1. To utilise the £4000 disbursement from the 2023/24 Discretionary Ward Budget to fund the study, rather than the 2024/25 Delegated Ward Budget.
