We are well embedded in the community, work with local schools to promote angling access and establish coaching for young people, in conjunction with the Angling Trust. We support Francis House Children's Hospital each year with funds raised from our 24 hour fish-athon, raising c £3,000 last year.

9. Please give us a brief description of your proposed/planned project or activityYou may wish to include details of what activities will take place, where will it happen, how often and who will take part. If you are applying for equipment you can tell us what will it be used for and why is it needed.

Councillor Racheal Wise was kind enough to visit us to discuss our plans. We are undertaking a range of major works, advised by expert bodies, to improve the pond and surrounding areas, upgrading access, safety and inclusion. We have work parties every month to maintain and improve the pond. Works include replacing old fencing, removing overgrown and inappropriate trees followed by a replanting programme, upgrading of pathways around the pond to further enhance access for able and less able bodied members, construction of floating islands to improve biodiversity, fish safety and spawning. We have cleared and reclaimed unused, unsightly and overgrown land around the pond to improve the outlook for surrounding houseowners and add additional facilities including a toilet, desalination plant, security cameras and club cabin.

Clearly all this work is producing a range of material that needs to be recycled/disposed of and we want to apply for funding towards a lockable skip that would reside on our car park area and be emptied by professionals on a periodic basis. We would want to have the skip emptied and replaced 3 times over the next 6-12 months.

10. Who will benefit from this grant?

Our club is open to anyone who wants to fish and we have a wide range of members from the locality. Full members are aged 16 upwards. Children can fish on the pond but must be accompanied by a responsible adult member at all times. We have access and specialised fishing pegs for less able bodied members.

By undertaking ongoing works to keep the pond and surrounding areas tidy, fit for purpose and safe/secure we are protecting our members and enhancing the environment generally for homeowners abutting the site.

The minimum currently is the 207 members plus surrounding homeowners.

11(a) How much will the project/activity cost in total?

An 8 yard lockable skip is £245 + vat per trip and we would like 3 collections making a total cost of £735 + vat.

11(b) Tell us about other any other sources of income you have already applied for or raised so far in relation to this project

We have not applied for any other funds in relation to skip provision but have accessed some funding from the Angling Trust for the desalination plant and biodiversity improvements.

In terms of raising income ourselves, our policy for years has been to give funds generated to local charities. Over the last 10 years we have supported Francis House Children's Hospital. In recent times we have raised roughly around £2,000-£3,000 a year for them.

Total cost of £735 + vat, giving £882.
