6. Please describe the main activities of your Organisation/ Group

We are group of local volunteers who make up the Friends of East Avenue Park. We are mostly local parents, who want a nice outdoor space for our families to enjoy. We are a small team. Our main aim is to make sure we have a nice greenspace and park for the local community to enjoy. We help to fundraise to keep the park and play equipment up to date and relevant for the community's needs. We also act as a go between for the community and the council. East Avenue Park is one of only two parks that serve the community of Heald Green, which has a current population of almost 13,000. We have quite a mixed demographic, with 16% of the local community being of Asian heritage. This is over 10% higher than the Stockport total population percentages. We also have over 300 extra new properties being built in the local area and East Avenue Park will be their local park. It is a very popular park with people running, cycling, playing on the play equipment, dog walking, playing football and even just sitting on the benches and watching the planes and the world go by. It is very rare to pass the park and no one be in it.

We try to make the park as accessible as possible, within our local area is both The Seashell Trust and The Together Trust and we have visitors from both frequently. The path around the park is very flat which makes it easy for wheel chair users. We have two lovely rainbow picnic benches with spaces for wheelchairs under them. Our play equipment is from an 'accessible' range. Our park also only as one entrance and exit which helps with safety for our visitors who are less aware of dangers. A couple of years ago we installed a bucket swing and toddler area within the park which you kindly donated towards. We are now reaching out for support with helping to install some fitness and gymnastic style equipment.

Our last fundraising mission was to install a bucket swing and toddler area after noticing a gap in what our park is able to offer. We have seen the delight on everyone's faces when we were able to install these and come rain or shine the bucket swing always seems to have someone on it! We have since reached out to the community, surveyed what people would like to see in the park and worked with the council to get a quote for our first phase of fitness and gymnastics equipment with possible more to come in the future. We try to be realistic with our aims of what we can achieve but want the very best for our community.

Fitness is great not only for health benefits but can also help to keep teenagers from acts of antisocial behaviour and getting themselves into trouble. By fundraising for a combi fitness piece of equipment we hope that the social side of keeping fit, and even competitive side, will encourage youngsters to use it for fun and fitness. Gymnastics is getting more and more popular and we find that girls especially are using the divider bars in the park to roll on. These are quite low and it would be great to give them somewhere to practice their rolls and balances whilst younger children are enjoying the climbing frame areas.

With higher energy prices and the cost of living increasing we are also seeing many more people use the park, come rain or shine, rather than opting for paid for leisure venues. It will demonstrate a lasting benefit to the community if we could achieve the target and they could see what we have been working towards.

Here are the pieces of equipment we hope to get enough funds to install along with their costs for supply and installation through Stockport Council.




