Summary: To approve an Experimental Traffic Regulation Order for No Waiting at An Time restrictions (double yellow lines) on Stitch Lane in Heaton Norris.

No Waiting at Any Time (Experimental Traffic Regulation Order):
Stitch Lane, Heaton Norris (Southern Part)
North West side from a point 11 metres South West of the South Western kerb-line of Wellington Road North for a distance of 12 metres in a South Westerly direction then Nort Westerly direction for a distance of 87 metres.
Stitch Lane, Heaton Norris (Northern Part)
East side from a point 21 metres South of the South Western kerb-line of Wellington Road North is a Southerly direction for a distance of 104 metres and to tie-in with the aforementioned.

Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

To approve an Experimental Traffic Regulation Order for No Waiting at Any Time restrictions (double yellow lines) on Stitch Lane in Heaton Norris.

2. BACKGROUND

Members will be aware of Stitch Lane which provides rear access to frontage residences and premises on Wellington Road North. The route provides access for refuse and recycling collections for the frontages as it would not be feasible to use the A6. Note: The residences include the apartments at Adam Court and Wellington Court.

It is reported (by the public and Council Officers) that refuse wagons are being physically obstructed due to on-street parking (the carriageway is just over 4 metres wide). Obviously, waste collection is an essential public service - and the refuse wagons need the route to be accessible as possible.

3. PROPOSALS

In order to improve the situation, a proposal has been drafted to install double yellow lines (No Waiting at Any Time) for the full extent along that side opposite the railway line. Please see attached drawing number: **NM8-5258-001 Rev A**. Note: The side adjacent to the railway line does not lend itself to the installation of double yellow lines as the edge of the carriageway is ill-defined in some parts. However, it is noted that motorists do not park on this side (next to the wall) as to do so would be impractical.

For the sake of expediency and in agreement with the local Ward Councillors, the order will be made on an experimental basis which means the lining work on-site will be coordinated with advertising the legal order. Residents and premises will be notified in advance and will have opportunity to return a formal objection(s) during the 18 month experimental period.

4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

5. FINANCIAL IMPLICATIONS

To be funded from the Reddish South Delegated Ward Budget.

6. TIMESCALES

If approved, the order is expected to become operative before the end of the year.

Stitch Lane, Heaton Norris (Northern Part)

East side from a point 21 metres South of the South Western kerb-line of Wellington Road North is a Southerly direction for a distance of 104 metres and to tie-in with the aforementioned.
