## Heaton Close, Heaton Moor

#### Report of the Director of Place Management

## 1. INTRODUCTION AND PURPOSE OF REPORT

To approve a proposed Traffic Regulation Order for No Waiting at Any Time restrictions on part of Heaton Close in Heaton Moor.

## 2. BACKGROUND

A Ward Councillor (Heatons South) contacted Network Management to raise local concerns about the parking situation on Heaton Close. As the carriageway is quite narrow (approx. 4.5 metres wide) it has been reported that larger vehicles can struggle for access due to on-street parking. There are also related concerns should an Emergency Vehicle need access into the cul-de-sac part.

## 3. PROPOSALS

In order to improve the situation a proposal was drafted for the provision of a Traffic Regulation Order No Waiting at Any Time (double yellow lines) along the full-length of one side to the cul-de-sac end. Please see the proposal shown on drawing number: **NM8-5242-001**.

#### 4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

## 5. CONSULTATION

In agreement with the Ward Councillors a local consultation was delivered on the above basis. The proposals did not receive any opposition and several written responses were returned to support the scheme. Note: The consultation document explained that it would be an offence for a vehicle to park opposite the double yellow lines in such a way as to obstruct access to a driveway (not unless the householder has given permission).
