Summary of updates provided during the September meeting:			
Update from Stockport Primary Care Board			
Items of discussion at the meeting included:			
<ul style="list-style-type: none"> • Focus on Urgent and Emergency Care capacity and access plans. • GP collective action • Primary and secondary care interface meetings with Stockport NHS FT. • Current financial position of NHS Greater Manchester (Stockport), including a predicted overspend on prescribing. • Emergency Care Improvement Support Team (ECiST) visit to Stockport NHS Foundation Trust. • Michael Cullen, Chief Executive of Stockport MBC and Place Based Lead had visited Stockport GP Board and had commended the excellent performance against the key performance indicators (see below). 			
GP Collective Action			
It was noted that Stockport submitted a form to NHS Greater Manchester (GM) to note any impact for the locality on collective action taken by GPs. There was minimal impact at this time. NHS GM had developed Tableau (software programme to collate data) to be able to look at trends across GM and at locality level within GM.			
Primary Care Quality Report			
Stockport had consistently met the national standard of 60% for completion of all six Serious Mental Illness (SMI) health check elements. It was noted that the data showed a fall in performance but practices were on track to achieve the target by the end of the year. It was pointed out that practices tended to complete the checks in the later quarter of the year.			
2024/25 Quarter 1 (Q1) data showed Stockport practices achieved a rolling 12-month performance of 82.6% for delivery of Learning Disability (LD) checks against a national year-end target of 75%.			
Friends and Family Test (FFT) data remained consistently high for Stockport (between 94 – 96%), including 82% rating practices as very good.			
Planning had commenced for mobilisation for the next round of Covid vaccinations. All Primary Care Networks (PCNs) had signed up to deliver the vaccine along with 37 pharmacy sites. GM had commissioned a roving mobile unit to target specific areas in Stockport, working with the public health team. There had been a 65% uptake for the Spring vaccine. There had been a strong uptake for the MMR vaccine this year and Stockport achieved the target consistently well compared to other areas in GM due to targeted work by members of the public health team. However, it was recognised that inequalities in uptake remained therefore the targeted work would continue.			
Stockport was in the top four in the country for uptake of flu vaccinations.			

Ten general practice quality assurance visits had been completed with another six visits scheduled. The visits enabled good practice and learning to be shared with other PCNs.

There had been no contract breaches issued to Stockport practices in 2024/25.

GP Patient Survey 2024

An update was provided on current data for the GP Patient Survey 2024; Stockport continued to perform well with two practices in the top for performance in the country – High Lane Medical Practice and Marple Medical Practice. It was noted that the questions asked of patients had changed significantly so it was difficult to benchmark against data from previous years.

Locally Commissioned Services update

It was noted that the performance data for 2023/24 had been closed as there had been no further appeals received from practices regarding payments received against measures achieved for the previous year.
