# PARKS, HIGHWAYS & TRANSPORT SERVIC PORTFOLIO HOLDER'S INTRODUCTION

I am pleased to be able to present this report at a time when so many positive developments are happening across our borough.

The new Interchange and Viaduct Park have been a great success. Seeing the park change through the seasons with so many plants and flowers on show has received positive feedback from many Stockport residents and visitors. The associated helix and walk/cycle bridge has connected areas of the town and enhanced people's experience of changing between buses and trains in Stockport. It is a testament to the innovative design that Stockport Interchange won the Design, Engineering and Construction Project of the Year category at the National Transport Awards on Thursday 3rd October.



This is just the start of our ambitions for this area. I continue to push for the Metrolink to come to Stockport, and eventually the tram-train, and an upgrade to Stockport Train Station and the rail capacity through there. Improving capacity on the West Coast Mainline at Stockport would not just benefit Stockport, but all the surrounding areas.

I also look forward to the planned opening of Cheadle Railway Station in 2026. Cheadle Railway Station will enhance the experience of residents and visitors to Cheadle and will link in well with the recent walk/cycle improvements in that area.

Improvements to the walk and cycle infrastructure across the borough continue at a pace. Significant improvements are nearing completion in Romiley. Plans are nearing completion in Bredbury and Woodley. There are improvements in progress in the Heatons which will link wider cycle infrastructure in Stockport to the Fallowfield Loop. Work is in progress on the Ladybrook Valley, which will link into existing walk/cycle schemes, including the A6 to Bramhall Park scheme. Improvements are being made around the new Marple Hub which will make the new facility there as accessible to residents as possible. The A34 scheme will benefit a range of transport modes, and progress continues apace on that scheme.

In January, Stockport will become part of the Bee Network bus franchising system. We look forward to welcoming improvements to the buses around Stockport, and I will continue to advocate for network improvements, as I know many areas in Stockport that are currently underserved by bus services.

In preparation for bus franchising, there are several bus infrastructure schemes planned or in progress, including a strategic bus corridor, and enhancements to junctions, crossings, and bus stops. It is within all our interests that the bus service operates as reliably as possible.

We continue the process of enhancing our offer in parks and there are several examples listed within the report. It would be a challenge to list them all here, but one particular scheme I would like to mention is the improvements to the BMX facilities at Bruntwood Park, which will allow the club to host competitions attracting riders from all over the country. I have asked for a particular focus on getting accessible play equipment into our parks across the borough when the opportunity arises. Our parks are further enhanced by the amount of work done by the continued efforts of volunteers and friends of parks groups, who not only carry out tidying and planting, but also run events

# PARKS, HIGHWAYS & TRANSPORT SERVICES 1. DELIVERING OUR PRIORITIES

This report is based on the **2024/25 Portfolio Agreement**, considered by Communities and Transport Scrutiny Committee on 10<sup>th</sup> June 2024 and approved by Cabinet on 25<sup>th</sup> June 2024. The link to the Agreement can be found by clicking <u>here</u>.

This Quarter 2 (Mid-Year) report includes updates on all **delivery projects**, **programmes and other initiatives** set out in the portfolio agreement, up to the end of September 2024 where this is available.

Data is reported for all **performance measures** included in the agreement that have been updated since publication of the 2022/23 Annual Reports. These are categorised to reflect the council's influence and responsibility as Council, Partnership or Contextual. These categories are used to determine the type of target used as numerical, comparator, direction of travel or if no target is set. Definitions for these categories and target types are included within the Agreement.

The updated Portfolio Performance Dashboards are published alongside these reports and these can be <u>found here</u>. They contain the latest data across the full set of portfolio measures, including historical trends and comparative data (where available).

The criteria for RAG ratings and direction of travel status are shown below. The rationale for any variations to this will be clearly highlighted within the commentary.

#### **Priority 1: Managing transportation infrastructure**

We will maintain and improve our highways and footways to manage traffic and encourage the use of more sustainable modes of transport. Progress with each of the delivery projects aligned to this priority in the 2024/25 Portfolio Agreement is summarised below.

#### Maintaining infrastructure

Work to deliver the Street Lighting LED project has continued and will be finalised in 2025-26. Work has begun on the delivery of the Capital Programme including the additional maintenance funding received as part of the Network North programme.

#### Improving infrastructure

Council officers are working closely with colleagues from Transport for Greater Manchester (TfGM) to continue to develop the strategic business case for Metrolink to Stockport.

The third phase of bus franchising in GM, which includes the Stockport area, is due to start on 5 January 2025.

Work is continuing on developing proposals for the redevelopment of Stockport rail station and the associated business case.

#### Road Safety

Officers have continued to monitor the delivery of the borough's four School Streets and assist where possible. We are also awaiting guidance from TfGM on its preferred approach to delivering future School Streets initiatives and how to access the funding opportunities to support this. Work has continued to expand the 20mph zones and limits in the borough, as has work to review road safety around schools as identified in the Capital Programme.

#### Flood management

Officers have continued to provide advice on planning applications and local issues, as well as working with the Environment Agency and United Utilities on several projects.

#### Commentary on performance

#### PHT 1.3 (Miles of 20 mph speed limits)

The mid-year forecast for completed 20mph schemes is low as the council is waiting for a number of schemes to progress through the various governance processes. There are several 20mph schemes forecast to be completed this year, including developer-led, Department of Transport-funded, local area-funded and TfGM-related schemes. The mid-year forecast is that approximately seven miles of 20mph schemes will either be approved or on-site by the end of the year.

#### **Priority 2: Strategic Transport Projects**

There are a number of key, transformational projects that need to be delivered to support the One Stockport Transport Plan and the Council Plan. The latest progress on these is set out below.

#### **Securing investment in Stockport Rail Station**

Work is continuing to develop the detailed proposals for the redevelopment of Stockport station with key stakeholders involved in the design development process.

#### Improving accessibility to Stockport's local rail stations

Officers continue to work with TfGM as necessary to bring forward improvements to station access. Work to implement schemes at Reddish North and Bredbury is continuing.

#### **New Cheadle Rail Station**

Work continues on developing the detailed design for the railway station. Discussions have progressed on the possible stopping and train patterns to Cheadle Station and engagement with the relevant national and sub-regional bodies will soon conclude. Physical site works are due to begin on site in January 2025, with initial site clearance, arboricultural work and preparatory construction works progressing first.

#### **Bringing Metrolink to Stockport**

The council continues to work with TfGM on promoting Metrolink coming to Stockport as part of its Next Stop Stockport campaign.

Council officers are currently supporting TfGM with the bidding and commissioning process to appoint consultants to progress the Strategic Outline Business Case. Once consultants are appointed, TfGM will be progressing to May 2025 to produce the initial business case for a new Metrolink line from South Manchester to Stockport/Hazel Grove.

TfGM's officers are working with Network Rail and council officers and have agreed a funding package and approach on the replacement of Greek Street road over rail bridge to safeguard future potential Metrolink/tram train routes. Work on replacing the bridge will begin in the spring of 2025.

#### **GM2040** and Stockport Transport Strategy

Work is continuing on developing elements of the Local Transport Plan for Stockport and officers are also supporting the work being undertaken by TfGM to refresh the Greater Manchester Local Transport Plan and the Greater Manchester 2040 Transport Strategy.

#### **Measuring Performance and Reporting Progress**

There are currently no performance measures associated with this priority.

#### **Priority 3: Sustainable transport**

Encouraging and facilitating the use of more sustainable modes of transport including bus, rail, walking and cycling and improving their accessibility. Progress on each of the delivery projects aligned to this priority in the 2024/25 Portfolio Agreement is summarised below.

Moving to low-carbon and active transport options like walking, cycling public transport The necessary preparation works on Romiley to Stockport scheme elements, Heatons Cycle link elements and the upgrade of Bridleway on the Ladybrook Valley have been undertaken. The first phase of the Romiley scheme is nearly complete with work due to start on site in the near future at Heaton Mersey Common and Ladybrook Valley. Other recent work includes:

- The Mayor's Challenge Fund Urban Traffic Control Schemes at Dale Street is complete.
- Activation work for the Interchange and the Heaton Moor road and Dale Street crossings are underway.
- The council also participated in the Stockport Moves event and engaged with schools and businesses as part of World Car Free Day on 22<sup>nd</sup> September.

#### **Bus Franchise Performance**

Officers are working with TfGM to coordinate the launch of the new franchise, which is scheduled to be operational on January 5, 2025. This includes agreeing methodologies to share information about network management activities on bus routes.

#### Electric vehicle (EV) charging

Work to deliver EV charging sites in partnership with Be.EV is progressing, with four sites now complete and the fourth site being energised in July. The council's legal team is currently working on agreements for the next five and they are expected to be finalised in Quarter 3, following licenses being agreed with Electricity North West for the related substations needed for the sites. The final EV site being provided by TfGM funding in Chadwick Street, Marple is in place and due to be energised shortly – this is later than expected due to technical issues.

# Priority 4: Well-maintained, clean and accessible public spaces in neighbourhoods

We will work in partnership with communities and partners to ensure that our shared public spaces are welcoming, clean, and safe. We will ensure that they are easy to access, utilise and enjoy with minimal litter in our town and district centres.

We will continue to develop our public realm as a place that promotes wellbeing with cared for, accessible greenspace available within a short distance for all our residents.

Progress on each of the delivery projects aligned to this priority in the 2024/25 Portfolio Agreement is summarised below.

#### Work with community groups

The team continues to provide training to local volunteer groups to ensure they are equipped with the skills to safely help maintain our greenspaces and parks.

The council's flagship Viaduct Park has benefitted from a focused approach to community coordination and has seen a successful and popular programme of community events since opening.

New 'Friends of' groups are forming, or have formed, including in Bruntwood Park – that group is establishing well.

#### Improving diversity and accessibility of our spaces

The greenspace team has now been organised on a neighbourhood basis and has been tasked with scoping the areas they are responsible for and starting work relating to greenspace standards. This will assess the neighbourhood and local green amenity space so that areas for development can be prioritised and support drawn in from volunteers (such as 'Friends of' groups).

The Quarter 2 forecast position for the Parks, Highways & Transport Services portfolio is a deficit of £0.300m which represents 2.2% of the cash limit budget of £13.507m.

The deficit is due to a £0.400m pressure on cremations income expected within Bereavement Services because the cremators have not been fully functional for part of the year. It is expected that this pressure will be partly offset by vacancy management in the Neighbourhoods service (£0.100m).

Potential overspends have been identified on Street Lighting and Highways reactive maintenance, however these deficits have not been included in the current forecast because it is envisaged that they will be contained by Totally Local Company.

#### 2.2 Earmarked Reserves

Most earmarked reserves are held at a corporate level and services produce a business case to draw down funds, which is approved through Corporate Leadership Team and Members. This strategic approach is designed to provide financial resilience for the council and to ensure that council reserves are used on an invest-to-save basis and to support council priorities. The exceptions to this are ringfenced reserves and the Directorate Flexibility Reserve.

The table below reflects planned use of reserves at Quarter 2 and is after the review of the council's reserve policy which was presented to Cabinet on 18 September 2024 (Agenda item 11)

Capital Asset Maintenance	
Street Lighting	This programme delivers the structural replacement or repair of street lighting columns and signs that are reaching the end of their life. Assets are identified for replacement or repair following routine structural / visual assessments. The condition of lighting columns and signs are being used to develop whole-life modelling of assets across the network.
Highways Drainage	The current year's programme is progressing as planned.  An ongoing programme of works to improve highway drainage across the borough. This includes drainage inspection and repair undertaken ahead of carriageway resurfacing works in the planned maintenance programme.
Pot Hole and Highway Maintenance Improvements	The current year's programme is progressing as planned.  A programme of carriageway resurfacing, footway repair and large-scale pate repair of the highway.  Preventative treatments have been completed and the main carriageway resurfacing work will take place in Quarters 3 and 4.
Highways Structures	A programme of condition surveys and inspections that identifies maintenance schemes and interventions including bridge deck waterproofing, bridge deck repairs, bridge bearing repairs, bridge parapet repairs, retaining wall repairs, steps refurbishment, and slope investigations.  This year's programme also includes the development and preparation of a scheme to replace the bridge deck on Queens Road in Cheadle. The delivery of the scheme will take place in subsequent financial years.  Of the 33 principal bridge inspections, all work packages have been issued during Quarter 1 and Quarter 2, and 2 have been completed to date.  The 2024/25 programme has been amended to include the replacement of bridge joints on the A555 near Handforth Dean.  Several schemes from the original programme will be developed this year but delivered next year to accommodate funding this change in programme, and design and preparation work is underway on those schemes.  Work is progressing to deliver the interventions planned in the remainder of this year's programme with 1 project construction project completed, 2 project currently on site and a further project due to go to site at the start of Quarter 3

<u>Major Schemes</u>	
SEMMMS Relief Road	The A6 to Manchester Airport Relief Road Scheme provides 10 kilometers of new 2-lane dual carriageway on an east-west route from the A6 near Hazel Grove (south east Stockport), via the four kilometers of existing A555 to Manchester Airport and the link road to the M56. The planned and actual spend represents Stockport's element of the final stages of the scheme notably around finalising land purchases, drainage works, part 1 compensation and Year 5 monitoring and evaluation.  Land acquisitions are progressing well, with the focus going forward relating to the more complicated land acquisitions, where for example, agreements have not been reached by negotiation and will be taken to tribunal for resolution.
	Validation of part 1 claims is nearing completion, with subsequent initial compensation payouts having been made.
	Investigation and design works for drainage improvement works have been undertaken with this being a key focus area in Quarter 3.
Town Centre Access Plan	A £73m package of measures that has transformed the accessibility and connectivity to and around Stockport Town Centre. The plan considered access by all methods of travel, specifically aiming to ease congestion for buses and general road traffic and encourage walking and cycling, as part of an ambitious vision and development framework for investment in the town centre.  The planned and actual spend represent the final stages of the scheme
	delivery as well as project and programme closeout and post opening monitoring and evaluation.  A mixture of grant funding and council funding is being used to undertake major repairs and improvements to the Merseyway bridge structure and
Merseyway Structure & Public Realm	associated public realm assets.  Works have progressed in Quarter 1 and Quarter 2 with work taking place on the ramp outside the former BHS and the reopening of Deanery Way North. Remaining works to complete the paving and barriers at the Warren Street end will be undertaken after Christmas. Close-out of the completed elements of the scheme is now taking place and will continue during the rest of the year.
Merseyway Carpark	A package of works across the Merseyway multi-storey car park to repair and waterproof the structure, to prevent further structural deterioration and extend its life. The package includes inspections and site surveys to develop a more complete understanding of the carpark structures and bridges. Works are to be delivered in a phased manner to maintain car park operations.
Maintenance & Refurbishment Project (Phase 1)	Resurfacing and repair works to Level 2 of the Yellow and Green Zone (above Primark) are now substantially complete. Survey and repair of the Pickfords Brow Bridge northwest joint is ongoing.
