Proposed Traffic Regulation Order 'No Waiting at Any Tiime' on the junctions of Lavington Avenue/Brookhead Drive, Lavington Avenue/St. Davids Road, St Davids Road/ Boundary Road and St. David's Road/Palmer Avenue, Cheadle Report of the Director of Place Management

#### 1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To report the findings of a consultation exercise and to seek approval for the introduction of a Traffic Regulation Order (TRO) 'No Waiting at Any Time' on several junctions located on the Boundary Road Estate, Cheadle.

#### 2. BACKGROUND

2.1. Traffic Services received a request from Highway Ward Spokesperson for the Cheadle Hulme North and Cheadle West Ward to investigate safety concerns as it had been reported that motorists are parking their vehicles too close to the junction and in doing so are obscuring visibility together with hindering traffic and pedestrian movement.

#### 3. PROPOSALS

- 3.1. Due to the nature of the concerns raised, Traffic Services proposed to introduce a series of Traffic Regulation Order (TRO's) as shown on the attached **Drawing No. NM8-5089-003.**
- 3.2. These proposals support Rule 243 of The Highway Code which states: DO NOT stop or park within 10 metres of a junction.
- 3.2 It is further proposed to install additional 'Give Way' Markings on the junctions to give increased awareness of the marked junctions, and to make clear that motorists are required to 'give way'.

#### 4. LEGAL POSITION/IMPLICATIONS

4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

# 5. CONSIDERATION OF ALTERNATIVE SOLUTIONS

5.1. Previously, letters have been delivered to residents asking them to park considerately however, this did not resolve the parking concerns.

#### 6. CONSULTATION

6.1. The Local Ward Councillors have been consulted and no adverse comments were received. Due to the area having ongoing parking capacity issues the Local Ward

Councillors wanted to review the junction protection based on the feedback received from the affected residents in this area. This has resulted in a reduction of the proposed double yellow lines on the junction of Boundary Road/St Davids Road and Lavington Ave/Brookhead Drive; this revision will still increase safety whilst at the same time still allowing parking for residents. **Drawing No: NM8-5089-003** refers.

- 6.2. Greater Manchester Police have been consulted and no adverse comments were received.
- 6.3. Affected residents have been consulted, with each receiving a consultation letter and consultation plan, **Drawing No. NM8-5089-001**. The consultation documents are attached for reference.

From a total of 134 no. letters that were hand posted to affected residents, 42 no. (31%) responses have been received. A full breakdown is detailed below:

Drawing No: NM-5089-003. Note, some of the restrictions have been reduced to 9 metres which is under the 10 metre standard protection on a junction. This is due to the historic driveways that exist on corner houses on the estate. The restrictions that are over 10 metres have been extended to consider the highway layout and the radius of the kerb line. This change to the proposed restrictions will still improve safety and visibility for all road users whilst enabling

residents to park.

# Additional Consultation Results - St Davids Road / Lavington Ave Junction

Local Ward Councillors agreed to a further consultation for the junction of St. Davids Road / Lavington Avenue.

Affected residents have been consulted, with each receiving a consultation letter and consultation plan, **Drawing No. NM8-5089-02**. The consultation documents are attached for reference.

A total of 25 no. letters were hand posted to affected residents, following which 6 no. (24%) responses have been received. A full breakdown is detailed below:

# **Proposed Traffic Regulation Order (TRO) Schedule**

# No Waiting at Any Time

# St Davids Road, Cheadle (West Side)

From a point 10 metres north of the intersection of the northwestern kerb line of Palmer Avenue to point 10 metres south of the southern kerb line of Palmer Avenue.

From a point 10 metres north of the intersection of the northern kerb line of Boundary Road to a point 10 metres south of the southern kerb line of Boundary Road.

# St. David Road, Cheadle (East Side)

From a point 9 metres north of the intersection of the northern kerb line of Boundary Road to a point 10 metres south of the southern kerb line of Boundary Road.

From a point 10 metres north of the intersection of the northern kerb line of Lavington Avenue to a point 10 metres south of the southern kerb line of Lavington Avenue.

# **Boundary Road, Cheadle (North Side)**

From a point 9 metres east of the intersection of the eastern kerb line of St. Davids Road to a point 12 metres west of the western kerb line of St. Davids Road.

# **Boundary Road, Cheadle (South Side)**

From a point 10 metres east of the intersection of the eastern kerb line of St. Davids Road to a point 9 metres west of the western kerb line of St. Davids Road.

# Lavington Avenue, Cheadle (South Side)

From a point 12 metres northwest of the intersection of the western kerb line of Brookhead Drive to a point 12 metres east of the eastern kerb line of Brookhead Drive.

# **Brookhead Drive, Cheadle (East Side)**

From the intersection with the southern kerb line of Lavington Avenue for 10 metres southerly direction.

# **Brookhead Drive, Cheadle (West Side)**

From the intersection of the southern kerb line of Lavington Avenue for 11 metres in southerly direction.

# Palmer Avenue, Cheadle (Both Sides)

From the intersection of the western kerb line of St. Davids Road for 10 metres in north westerly direction.

# Lavington Avenue, Cheadle (Both Sides)

From the intersection of the eastern kerb line of St. Davids Road for 10 metres in south easterly direction.
