Seashell supports children and young adults with the most complex disabilities in the country to reach their potential and live their best lives through our Cheadle-Hulme based specialist school, college, residential care facility and outreach services that reach over 8,000 people a year.

With a rich 200-year history, Seashell was founded as the Royal Schools for the Deaf in 1823, bestowed with royal patronage from Queen Victoria. Originally residing in Salford, we moved to our site on Stanley Road in Cheadle-Hulme in the 1950s.						
Reconstituted as the Seashell Trust in 2008, we are now one of only a handful of specialist education charities to support children and young adults with multiple and highly complex needs.

## **9. Please give us a brief description of your proposed/planned project or activity**You may wish to include details of what activities will take place, where will it happen, how often and who will take part. A recent study by Greater Manchester Moving identified **high levels of inactivity** in Stockport with **1 in 4 adults** and **over half of children** living in the borough experiencing inactivity. Over **70%** of disabled people in the UK say they want to be more active but don't get the opportunity. In areas like Stockport there is a of lack any form of inclusive fitness provision to help disabled communities to get fit and improve their wellbeing.

We believe the local disabled community deserve better than this.

That's why we would be delighted if you would support CADS, our award-winning sports and activities programme for children with complex disabilities in the local area.

Now in its 20<sup>th</sup> year, CADS supports over **300 disabled children** a year to develop their confidence, self-esteem, health and fitness through clubs in the school holidays and every Saturday through access to the following activities:

- Sports such as cycling, football and sensory tennis (right).
- Creative and wellbeing activities like crafts and yoga.
- Special events including inclusive drama with partners Triple C and animal handling with Home Safari.

Unlike other holiday clubs and community sporting provision, we offer 1:1 support for children, which means they can engage in activities in a safe and supported way.

Because of his complex needs and challenging behaviours, it is almost **impossible** for Tom to attend any inclusive social/play sessions. CADS gives him the chance **to do things other children do** in an environment where he feels secure and happy. He has developed friendships and that's just so important to him." We are specifically requesting support towards inclusive activity costs from local providers to include inclusive yoga, animal handling and drama classes.

#### 10. Who will benefit from this grant?

e.g. local residents, young people, older people and how?

Local children with multiple and complex disabilities to include learning and communication difficulties; multi-sensory impairments; neurological conditions like severe autism, mobility issues; acute health conditions and rare genetic syndromes.

#### 10(a) How Many Stockport residents will benefit?

Last year, CADs supported 302 young people from the local area. With 60% of participants attending from the borough of Stockport we expect the grant will benefit approximately 180 children with disabilities from Stockport who we expect to attend CADS this year.

#### 10(b) Are there any restrictions on who will benefit from the funding?

Only children with complex disabilities are eligible to attend CADS and benefit from the funding.

#### 11. Your Project's Budget

#### 11(a) How much will the project/activity cost in total?

CADS costs £87,000 to run which covers the costs of sports equipment, activity delivery providers and staff time.

## 11(b) Tell us about other any other sources of income you have already applied for or raised so far in relation to this project

We have secured the following grants towards the cost of delivering CADS over the next year:

£40,000 from Children in Need: CADS beneficiary Bailey was recently featured on the Children in Need tv show. Paddy McGuiness visited Seashell's inclusive cycling track as part of his CiN fundraising cycle challenge and met our CADS beneficiaries.

£15,000 from the North West Young People's Development Trust

£3,000 from the Russell Trust

This leaves us with a shortfall of £29,000 which we are continuing to fundraise for.

#### 12. How much are you applying for from the Ward Flexibility Budget?

We invite external providers to come into CADS to deliver bespoke inclusive sporting events and activities.

We are requesting £832 to cover the following activity costs for our Saturday and holiday CADS programme over the next year:

X8 Inclusive yoga sessions with Yogability: £315 x5 Rebound Therapy sessions with Bounceback: 237 X5 Inclusive sports sessions with LuSu sports: £280

## 12(a) If the amount you are applying for covers only part of the project/activity, then please tell us how do you intend to fund any shortfall?

The total budget for external activity costs for CADS is £5,000 and we have applications currently pending with several grant making trusts to cover these costs including the Blair Foundation, Oldhurst Trust and Northern Customer and Community Improvement Fund.
