Installation of Bollards on Finney Lane / St Ann's Road South Junction, Heald Green

Report of the Director of Place Management

1. INTRODUCTION AND PURPOSE OF REPORT

1.1 To seek the approval of the supply and installation of 2 no. Middleton Bollards at the junction of Finney Lane and St Ann's Road South, Heald Green, to prevent motorists from driving their vehicles over the footway to avoid queuing traffic turning right onto St Ann's Road North.

2. BACKGROUND

- 2.1 It has been reported that motorists are bumping up the kerb and driving over the footway outside 95 Finney Lane at the junction with St Ann's Road South to avoid queuing vehicles that are waiting to turn right into St Ann's Road North.
- 2.2 This driver behaviour is causing serious safety issues for pedestrians walking in the area as it's a busy route for motorists and pedestrians due to its proximity to the local amenities.

3. PROPOSALS

3.1. To address the concerns raised and prevent motorists from driving over the footway to avoid queuing traffic, it is proposed to install two bollards on the corner of the junction to deter motorists from mounting the footway to avoid the queuing traffic. The proposals are shown on **Drawing No. NM18 -6431-01.**

Supply and installation of 2 no. Middleton bollards as per SMBC standard detail with ballotine rings/reflective strips.
