The equipment we are applying for is to enhance the training sessions for all the children in the Stockport County Ladies Junior Football Club's U8 and U9 teams.

Sport and activity supports children to be physically and mentally healthy, setting good habits for their lifetime, promoting the 'One Heart' ambition of the One Stockport Borough Plan.

This opportunity to seek additional equipment for the girls football fits into the aim of the One Stockport Borough Plan - the 2030 vision to make Stockport a great place to grow - where people feel part of a community which supports them to feel valued, loved, happy and healthy. A community where children and young people to have the best start in life, can be happy, safe and be able to build healthy relationships which will enable them to thrive. This also aligns to the ambition from the Stockport Council Plan which is that every neighbourhood and community across the borough can access the services that they need to be resilient, healthy and vibrant.

The girls' teams are doing really well in their respective leagues against other Cheshire football clubs in which they are showing improvements week on week with smiling faces. This healthy competition increases a sense of belonging, respect, teamwork, resilience and confidence. It makes the girls and their families feel that Stockport is an exciting place to live and grows our talent for the future.

We are requesting funding for the following specific equipment:

12 training poles with weights (£120) –

These will help develop the girls' agility, ball control, and dribbling skills through various training drills. The poles create obstacles that players must navigate around, improving their footwork and coordination.

4 sets of mini goals (£180) -

These will allow us to set up multiple small-sided games during training sessions, ensuring all players get maximum touches of the ball and shooting practice. This develops technical skills and decision-making in game-like situations. The existing goals are too big.

Coloured cones (various) (£60) -

Essential for marking training areas, creating skill challenges, and designing varied practice routines. Different colored cones allow coaches to create more dynamic and engaging training sessions.

2 sets of goalkeeper gloves (£60) -

Proper protection for our young goalkeepers, allowing them to develop confidence in handling the ball and making saves safely. Appropriate-sized youth gloves are essential for their development.

2 top bins corner targets (£70) –

These targets attach to goals to improve shooting accuracy and precision. They create specific targets for players to aim at, developing better finishing techniques.

8 football passing arches (£160) -

These will help develop passing technique and accuracy - a fundamental skill at this age group. Players can practice passing through the arches, improving their ability to connect with teammates.

2 rondo football rings (£90) -

These enhance close control and team possession work, developing the technical skills needed in modern football. They create a defined space for possession games and technical drills.

2 captains armbands (youth size) (£36) -

These promote leadership and responsibility among our young players. Each team will have an armband to rotate among players, developing communication skills and confidence.

Equipment bag (£110) -

Proper storage and transport of all this equipment, ensuring its longevity and organization.
