South East side, from a point 5 metres North East of the North Eastern kerb line of Claremont Road in a South Westerly direction to a point 5 metres South West of the South Western kerb line of Claremont Road.

Woodsmoor Lane (Davenport & Cale Green Ward)

North Western side, from a point 10 metres North East of the (projected) North Eastern kerb line of Claremont Road for a distance of 21 metres in a South Westerly direction.

#### Report of the Director of Place Management

## 1. INTRODUCTION AND PURPOSE OF REPORT

To make permanent an experimental Traffic Regulation Order (TRO) for No Waiting at Any Time restrictions on part of Woodsmoor Lane in Woodsmoor.

## 2. BACKGROUND

Members will recall that an experimental order for No Waiting at Any Time restrictions (double yellow lines) was approved in August 2023 on Woodsmoor Lane at the junction with Claremont Road. The purpose of the restriction was to facilitate turning movements for coaches serving the nearby infant and junior schools.

For the sake of expediency, the order was made on an experimental basis (operative from September 2023) so the yellow lines could be installed on-site within the shortest possible timescale.

The experimental TRO is effectively on advert for 18 months after which a decision needs to be made on whether the TRO should be made permanent. As things stand (March 2025) Legal Services have not received any formal objections in relation to the order and the officer in charge is not aware of any complaints. In the expectation that no formal objections will be forthcoming, it would be prudent to approve the TRO as permanent now - in readiness for when the experimental period has expired.

Note: The associated legal and lining costs for the TRO were approved as part of the original report in March 2025.

## 3. PROPOSALS

The restrictions are delineated on drawing number: NM8-4558-001.

## 4. LEGAL POSITION/IMPLICATIONS

The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

# 5. TIMESCALES

The experimental order is expected to be made permanent in 2025.
