**Proposed Traffic Regulation Order 'No Waiting At Any Time' on Northgate Road,  
Chatham Street and Eldon Road, Edgeley**

**Report of the Director of Place Management**

**1. INTRODUCTION AND PURPOSE OF REPORT**

- 1.1 To report the findings of a consultation exercise and to seek approval for the introduction of a Traffic Regulation Order (TRO).

**2. BACKGROUND**

- 2.1. Traffic Services received a request from the Highway Ward Spokesperson for the Edgeley Ward to investigate safety concerns as it had been reported that vehicles are parking close to the junctions of Northgate Road, Chatham Street and Eldon Road, obscuring visibility and hindering traffic movement.

**3. PROPOSALS**

- 3.1. Due to the nature of the concerns raised, Traffic Services propose to introduce a Traffic Regulation Order (TRO) – 'No Waiting At Any Time'. These proposals are shown on **Drawing No. NM8-5264-01**.

**4. LEGAL POSITION/IMPLICATIONS**

- 4.1. The Traffic Management Orders would be made under Section 1 of the Road Traffic Regulation Act 1984. The Council is required by the Local Authorities Traffic Order (Procedure) (England and Wales) Regulations 1996 to give notice of its intention to make a Traffic Order (by publishing a draft traffic order). These regulations also require the Council to consider any representations received as a result of publishing the draft Order.

**5. CONSIDERATION OF ALTERNATIVE SOLUTIONS**

- 5.1. No other alternatives were considered.

**6. CONSULTATION**

- 6.1. The Local Ward Councillors have been consulted and no adverse comments were received.
- 6.2. Greater Manchester Police have been consulted and they have no objections to these proposals.
- 6.3. Affected residents have been consulted with and from a total of 6 letters delivered, 1 response (17%) has been received. Of the responses received, 1 response (100%) is in support of the proposals and 0 responses (0%) do not support the proposals.

## Comments made by those in support of the proposals:

Comments	Traffic Services Response
I agree with the parking concerns and poor visibility. However this is mainly when there is a sports event on at the Alexandra Pub. Cars do not use the car park and it has now been reduced in size. Putting yellow lines I fear will not prevent this as traffic wardens will not be present at night when the majority of bad parking occurs so it is only going to penalise residents. I would also like to request 5m of DYL outside my house rather than 10m on Northgate Road. There is no problem with parking on this section so again it will only penalise us and other residents on this side.	These proposals compliment Rule 243 of The Highway Code, which states: DO NOT stop or park within 10 metres of a junction.

## **Appendix A**

### **Proposed Traffic Regulation Order (TRO) – ‘No Waiting At Any Time’**

#### **Chatham Street, Edgeley – Both Sides**

From the intersection of the eastern kerb line of Northgate Road for a distance of 10 metres in a north easterly direction.

#### **Eldon Road, Edgeley – Both Sides**

From the intersection of the western kerb line of Northgate Road for a distance of 10 metres in a south westerly direction.

#### **Northgate Road, Edgeley – East Side**

From a point 10 metres north west of the intersection of the northern kerb line of Chatham Street to a point 10 metres south east of the southern kerb line of Chatham Street.

#### **Northgate Road, Edgeley – West Side**

From a point 10 metres north west of the intersection of the northern kerb line of Eldon Road to a point 10 metres south east of the southern kerb line of Eldon Road.
